## Lions Clubs International MD-31 North Carolina Lions 2009-2010 Council of Governors

#### Saturday, February 6, 2010

Council Chairperson Paulette Gasperson called the third meeting of the 2009-2010 North Carolina State Council of Governors to order at 9:00 AM.

District Governor Marti Hill led the Pledge of Allegiance and District Governor David Osborne gave the Invocation.

For the record, the Council met in caucus on Friday evening, February 5, 2010. Seven of the eight District Governors were present.

CC Gasperson welcomed all to the third State Council Meeting of the 2009-2010 Lions Year.

Governor Greene moved to approve the Agenda for today's meeting; seconded by Governor Henry.

Motion passed.

There were no members of the International Family present at the Council Meeting.

State Secretary Kelly read a letter received from Lions Clubs International (LCI) regarding the cancellation of the Charter of the Bladenboro Lions Club in District 31-F, effective 12/21/09.

Governor Hill moved to accept the Minutes of the November 7, 2009, State Council Meeting as distributed to all District Governors by e-mail and as published on the web site; seconded by Governor Boudreau. Motion passed.

Council Secretary-Treasurer Kelly presented the State Council Financial Report dated 01/31/10. He stated that the ledger and bank accounts have been reconciled and all bills have been paid. He noted that all dues for the first half of the year have been paid and that the invoices for the second half were mailed on February 2<sup>nd</sup> and would be due on March 10<sup>th</sup>. He then pointed out line item 190 which now includes the \$8,000.00 representing the \$1,000.00 to each of the districts from State

Council Reserves which will augment their funds for the "Lions in Sight" advertising program. He ended his report with a review of the Money Market Account.

Governor Hill moved to accept the State Council Financial Report; seconded by Governor Osborne.

Motion passed. (See Attachment B)

Council Chair Gasperson then opened the floor to each of the District Governors to come to the podium to discuss their "State of their District." The following is a summary of their comments:

<u>District 31-A:</u> DG Marti Hill reported that her district was quite busy with the "Lions in Sight" Project with several TV spots being viewed in her area. In addition, four (4) billboards are planned in strategic areas around her district and several newspaper articles have been run in the Asheville Citizen-Times talking about what Lions do in their local communities. Membership continues to be a problem with a minus 20 year-to-date. In closing, she noted that her concentration from here until the end of June will focus on building membership.

<u>District 31-B:</u> Due to weather conditions DG Dot Nichols was unable to attend the Council Meeting. However, she did e-mail her report which stated that 31-B is having a good year. They are working very hard to get membership up and in the plus. They held a MERL Workshop at Camp Dogwood in January led by State Extension Chair Larry Gasperson. Further, a LCI New Club Workshop is planned for March 4, 5, & 6<sup>th</sup> at the Longview Lions Club with PDG Jim Cannon. Hopefully, she said, we can increase the members of one club and have a new one.

<u>District 31-D:</u> DG David Osborne noted that while his district is lagging in membership he has planned an LCI New Club Workshop for early March. His emphasis, he said, is to form both a Latino Club and one or two Campus Clubs.

<u>District 31-E:</u> DG Theresa Matthews reported that membership in 31-E is rebounding and they are in positive territory at +5. White Cane is above last year's figure at this time. There will be an Extension Workshop on March 21-23,2010 for the Belmont Area with PDG Jim Cannon from LCI conducting the sessions. She concluded by saying that their Mid-Winter Convention was very successful.

<u>District 31-F:</u> DG Dan Boudreau stated that while they are currently struggling with membership, especially with regard to Campus Club, they have formed a new Lions Club in Angier. He stated that his two Vice-District Governors are very active throughout the district. He added that while both White Cane and Camp Dogwood Raffle sales are lagging behind he is confident that they will exceed their goals for the year.

<u>District 31-G:</u> DG Don Henry opened by saying they while his district is continuing to bring in new members retention efforts are lagging with the net result being a drop in total membership. His two Vice-District Governors are active, he said, and are working very closely with the Zone Chairs in the areas of membership and retention. As a result of this he now expects his district to finish in plus territory for the year.

<u>District 31-H:</u> DG Al Greene stated that with the way things are progressing in his district they should finish the year with four new clubs and a branch club. His goal this year is for 1,000 members in the district. White Cane is \$6,000.00 ahead of last year, he said.

<u>District 31-J:</u> DG Bob Walton reported that with the 37 new members from the chartering of a new club in Washington, NC they are in positive territory with a net +20. He is now optimistic, he said, from this experience that they could form an additional new club this year in either Belhaven or Roanoke Island. With regard to White Cane, he noted that they were over 50% toward their goal.

Council Chair Gasperson thanked the Governors for their reports.

Council Chair Gasperson called upon Lion Curtis Erickson, the 2010 State Convention Chair for his report. He stated that his committee will now be meeting monthly. The Registration Committee is already receiving registrations, he said, and the registration form and ad forms are available on the NCLF website. He concluded his remarks by saying that the Convention Committee needs approval from the Council of Governors for such items as the schedule of events, cost of vendor tables, rules of procedure, and state convention committees.

Governor Hill moved to approve a \$100.00 charge for vendor tables at the State Convention; seconded by Governor Greene. Motion passed. This motion was subsequently modified by Governor Matthews to read that the \$100.00 fee be waived for agencies with a direct connection with Lions; seconded by Governor Walton. Motion passed.

Governor Boudreau moved that the head table be two tiered with the District Governors, International Family, the Honored Guest Speaker and the sitting Council Chair on the top tier. The First Vice-District Governors, the Council Chair-Elect and Council Secretary Treasurer be placed on the second tier. The Second Vice District Governors will sit at reserved round tables in the front of the room. Also, a reserved table will be set up for the NCLF Family; seconded by Governor Henry. Motion passed.

<u>Note:</u> It was agreed that the men would wear white dinner jackets and their adult companions\_would wear formal attire.

Governor Matthews moved that the pictures of the 2<sup>nd</sup> Vice-District Governors appear in the Convection Program; seconded by Governor Hill. Motion passed.

CC Gasperson recognized PDG Joe Silvers for a discussion of the 2010-2011 State Convention. He in turn recognized PCC Brad Logsdon, Chair of 2010-2011 State Convention who stated that he has booked the Holiday Inn Bordeaux in Fayetteville, NC for June 16<sup>th</sup> through the 19<sup>th</sup> 2011. He has blocked 192 rooms at \$85.00 per night plus tax. He has prepared three pages of ads for each District's Convention Programs inviting all Lions of that district to attend the Fayetteville State convention. Further, he will be sending invitations to the surrounding Multiple Districts to come to the 2011

Convention. He said that First International Vice President Sid Scruggs, III is projecting 900 attendees as it will be his last event of his International Presidency.

PDG Joe Silvers invited Lion Mike Schwartz to come to the podium to talk about the 2011-2012 State Convention. Lion Mike stated that District 31-E would like to host the State Convention in Charlotte, NC and once the State Council approves their request his committee will begin looking for a location. He went on to describe all the attractions in the Charlotte area.

### Governor Boudreau moved that the Council approve District 31-E to host the 2012 State Convention in Charlotte, NC; seconded by Governor Greene. Motion passed.

Council Chair Gasperson recognized NCLF President John Miller. Lion John remarked that he has put quite a few miles on his truck visiting Clubs all the Lions districts in the State. He noted that both White Cane and Camp Dogwood Raffle Ticket Sales are up this year. He has been in contact with the State Governors office, he said, regarding having a recurring proclamation naming Volunteer Week at Camp Dogwood as Lions Week throughout the State.

Council Chair Gasperson made the announcement that the Peace Poster winner this year came from District 31-F. Elijah Poe, a student at West Pine Middle School in West End, NC. The sponsor was the Seven Lakes Lions Club.

Council Chair Gasperson began the Committee Reports by calling up the MERL Team for their reports. She noted that Membership Chair PCC Gary Greene was unable to attend due to a conflict with family matters and that Extension Chair PDG Larry Gasperson was at home recovering from a knee replacement operation.

<u>Membership</u>: Though absent from the meeting PCC Gary Greene submitted his report which may be viewed in the attachments. (See Attachment D)

Extension: As noted above, PDG Larry Gasperson was unable to attend the Council Meeting.

**Retention:** PCC Harvey Whitley began his presentation with a graphical illustration of our members added versus members dropped through January 31<sup>st</sup>. As of that date, he said, we stand at -83 with a total membership of 8,553. He reiterated the mantra that "retention goals are best achieved at the club level." It is imperative, he said, to recognize that a new member joined your club for a purpose and that if you meet that need your retention problem will fade away. Year to date, we have added 566 new members but this was offset by 649 drops. (See Attachment E)

<u>Leadership:</u> PDG Ron Staley announced that the next training session for the District Governors-Elect will be held at Camp Dogwood on February 19,20, and 21<sup>st</sup>. This training, he said, will include Cabinet Secretary-Treasurer training and a seminar by Ginny Woolard for Spouses. He went on to state that he has submitted a request for reimbursement of training expenses to LCI. He concluded his remarks by announcing that PCC Martha Butler will be inviting the First Vice District Governor-

Elect's and each district's MERL Teams to Camp Dogwood on May 15<sup>th</sup> & 16<sup>th</sup> for a workshop.

Global Membership Team: PCC Martha Butler thanked the MERL Team Chairs for their continued dedication and hard work while she was laid up from back surgery. The bulk of her report centered on the MERL Workshop to be held at Camp Dogwood from 9:00AM on May 15<sup>th</sup> through noon May 16<sup>th</sup>. This workshop, she said, will be held in conjunction with training with the 2010-2011 First Vice District Governors. (See Attachment G)

<u>Unfinished Business:</u> PCC Dave Butler sought approval for the official 2010 crossed flag State Convention Pin. He needed to verify that the crossed flags would be Georgia and North Carolina and the number to be ordered would be 600 pins.

Governor Boudreau moved that the official 2010 State Convention Pin bear the crossed flags of Georgia and North Carolina and the quantity be set at 600; seconded by Governor Matthews. The Motion passed.

**New Business:** PCC Harvey Whitley announced that he would be a candidate for LCI International Director in 2012.

Council Chair Gasperson requested that Governor Greene come to the podium and call up the statewide committee chairs for their reports.

Boys & Girls Homes of North Carolina: PCC W.Brad Logsdon began his report by noting that the Christmas Party had an outstanding turnout. The Lions Cottage, he said, won the best decorated cottage award. He went on to discuss the upcoming March Clean-Up day and held out an invitation to all to join in this event. In closing he remarked that one of the boys at the cottage named Coby was 6' 5" tall and an excellent basketball player. This young man, Brad said, would like to attend a basketball camp this summer and was looking for some sponsorship money. (See Attachment H)

**Campus Clubs:** PDG Sydney Eudy was unable to attend and did not submit a report.

Constitution & By-Laws: PDG John O'Malley stated that his Committee reviewed the State Constitution & By-Laws and the State Policy and Procedures Manual and is recommending a number of changes: one (1) to the Constitution; two (2) to the By-Laws; and, five (5) to the Policy and Procedures Manual. As each of these recommended changes require a separate motion to approve, the changes and the state council members making the motions and seconds can be viewed in the attachment. (See Attachment I)

<u>Diabetes Awareness:</u> Lion Bill Barnwell began his report by asking the question; who here today knows their glucose level. If it's over 110 a lifestyle change is in order, he said. Each of the governors received a pamphlet called the North Carolina Diabetes Prevention & Control Fact Sheet which can be viewed in the attachments.

<u>Historian:</u> Lion Marlene Wooten reported that the publication of the History of North Carolina Lions Clubs is still in the publication phase. (See Attachment K)

Information Technology: PDG Paul Bledsoe was unable to attend but did submit his report via e-mail. He noted in his report that we are currently running a TV campaign throughout NC. He said that the schedule will last for several weeks with primary dollars lasting for 4 weeks. No charge commercials will run through late March and early April, he said. (See Attachment L)

<u>Leo:</u> Lion Terry Cauble submitted his report via e-mail noting that Districts E,F, and G Leos were active and doing fundraisers and attending Lions functions. The State Leo Convention will be held at Camp Dogwood February 26th through 28<sup>th</sup>. (See Attachment M)

<u>Celebrate Liberty:</u> PDG Mike Covell stated that March is the primary month for Celebrate Liberty events with the focus on March 16<sup>th</sup>, James Madison's birthday. Celebrate Liberty pins are being distributed with the cost at \$2.25 per pin.

<u>Lions Alert:</u> PDG Dale Dupree noted in his report that the Lions Alert Program continues to grow with programs being presented at Fall & Mid Winter Conventions. (See Attachment O)

<u>MD LCIF Coordinator:</u> PCC Harvey Whitley's report centered on the extraordinary work Lions have been doing in Haiti following the devastating earthquake that struck there. Lions Hope for Haiti has mobilized more than \$1.8 million to date. (See Attachment P)

**Nominating:** PDG Carlton Metts submitted his report listing each districts election results for District Governor, First & Second Vice District Governor, etc. (See Attachment Q)

Promotions: PDG Dave Martin will report at the Promotions Committee Meeting.

Youth Exchange: PDG Jerry Mertz was unable to attend and did not submit a report.

(Lions) Quest: PDG Morris Van Vleet was unable to attend and did not submit a report.

<u>Women's Leadership:</u> PCC Diane Whitley presented a graph showing the number of male and female lions in each district and remarked that female lions represent approximately 18-30% in our multiple districts.

A motion was made by Governor Hill to accept the Committee Reports; seconded by Governor Matthews. The Motion passed.

There being no further business, the meeting was adjourned at 11:23 AM.

#### STATE MEMBERSHIP REPORT

Governors, my apologies for not being to join you this weekend. I hope this report will give you a global update on the State of Lions Membership in North Carolina.

My congratulations to District E at Plus 5 and District J at Plus 22 who are positive in membership growth for the year. You have highly capable District Membership Chairs who are helping with your success.

So where do we stand in the state at this point? Numbers do not tell the whole story, but here's a quick snapshot by the numbers. Overall, our statewide membership has fallen by 1.55 percent over the past 12 months. It sounds small, but this represents 135 fewer Lions – the equivalent of almost seven clubs. However, there are some bright spots.

- Districts F and H membership numbers exceed their numbers from a year ago. New club development and district-wide membership recruitment are at the heart of their success.
- District H leads the state in new member recruitment with 78 new Lions thus far. Districts F, E, and J are not far behind. We have had one district that has recruited as few as 17, but I'm sure those numbers are sure to turn around.

Membership recruitment as a whole is holding steady. Last year at this point, we recruited 424 new Lions; this year, we stand at 418.

But of course, we are not satisfied with simply holding steady. To reach our statewide goal of 10,000 Lions by June 2011, we have quite simply got to reach for that higher gear. There are Lions throughout the state that have been working quite hard for some time now.

I continue to hear positive reports from Debbie Hicks out of District A who is working tirelessly to increase membership there. PDG Carlton Weeks over in District H has made 10 presentations in his district and has himself recruited new Lions. He says, "I feel very confident that by year's end we will be at a plus membership." The word from Lion Rich Beck over in District B is equally heartening. Most of his clubs have had membership dinners with some success. In North Wilkesboro, the Lions there had a meeting with the Millers Creek Fire Department to ask them

about membership; 45 firemen showed up and expressed a strong interest in joining. Lion Rich himself has recruited new Lions and has some more nipping at the bait.

There are reports that several clubs participated in the Lions In Sight promotion encouraged by President Eberhard Wirfs. And as you know, the fantastic television campaign spearheaded by PDG Paul Bledsoe is under way. Governors, I encourage you to use the pre-written news releases Lion Paul has provided to you. Be sure to ask your Public Information and Education District Chair to send the releases to your media list.

In the coming months, expect to see more articles in your district newsletters about membership. Please continue to encourage your clubs on your club visits about the importance of bringing together more hands to help in our local communities. My best to each of you.

#### Retention Committee Report MD 31 Council of Governors February 6, 2010 Asheville, NC

As part of my report in November, I included a graphical presentation of our members added versus members dropped through October 2009. I have updated this report with data available through January, 2010. At the end of October, 2009, we had an overall gain of +3 since the beginning of our Lions year in July. At the end of November, we were +8. Then came the December housecleaning and we fell to -74. As of January 31<sup>st</sup> we stand at -83 with a total of 8,553 total members. As I said in my last report, if you were running a business and this reflected your employees hired and employees quitting would this be a major concern that you would want to aggressively address?

Retention goals are best achieved at the club level. Each club needs a club retention chairperson who will assure that drops are addressed. Each club needs to do a self evaluation as to how they can improve their retention. Support must come from the top, but the real difference in improving retention will happen at the club level.

Along with club level evaluations, a strong orientation program is needed. Orientation is just like training a new employee in a business. New Lions must be trained and put to work or they will be out the door.

A friend of mine from the Memphis Forum Host Committee recently shared with me the following:



## **Diabetes** in North Carolina





- In 2008, North Carolina ranked 17th highest for adult diabetes prevalence among all states in the U.S. 1
- An estimated 643,000 North Carolinians or 9.3 percent of the total state adult population had diagnosed diabetes in 2008.2 Another 232,000 were estimated to have undiagnosed diabetes. There were an estimated 376,000 adults with prediabetes 3 in the state. Altogether, an estimated 1.25 million adults in North Carolina had some form of hyperglycemia (high blood sugar levels) in 2008.

#### Disparities

- In 2008, African Americans had the highest diabetes prevalence rate at 15.6%, followed by the Native Americans at 12.4% in the state.
- Diabetes is a disease of old age. More than one in every five North Carolina residents, aged 65 and over, had diagnosed diabetes in 2008.
- Adults with less than high school education had higher diabetes prevalence than college graduates (13.6% vs. 6.3%).
- North Carolina adults with household incomes less than \$15,000 had the highest rate of diabetes compared to people with \$75,000 or higher (16.7% vs. 5.4%).

#### **Risk Factors**

- Obesity: Obesity is a major contributor to type 2 diabetes. North Carolina ranked 8th worst for adult obesity in 2008 at 29.5%. <sup>1</sup> More than half (51.8%) of adults with diabetes were obese in the state in 2008.
- Physical activity: Physical activity helps control not only blood sugar but also weight and blood pressure, and it may improve cholesterol levels. Physical activity also reduces the risk of common diabetes complications, such as heart disease and nerve damage. Only 31 percent of North Carolina adults with diabetes reported 30+ minutes of moderate physical activity 5 days or more per week or vigorous physical activity for 20+ minutes 3 days or more per week in 2008.
- Healthy diet: People with diabetes have to follow
  a healthy diet that includes fruits and vegetables,
  whole grains, lean protein, low-fat dairy products and
  moderate amounts of healthier fats. In 2008, about
  80 percent of adults with diabetes did not consume
  five or more servings of fruits and vegetables in North
  Carolina.

- Smoking: Smoking has devastating effects on people
  with diabetes. Smoking raises blood glucose (sugar) and
  reduces body's ability to use insulin, thus resulting in
  poor diabetes control. Smokers with diabetes are eleven
  times more likely to have a heart attack or stroke than
  people without diabetes and do not smoke. 15.9% of all
  adults with diabetes smoked in North Carolina in 2008.
- From July 2008 to June 2009, among people who called North Carolina Tobacco Use Quit Line, 9.8 percent reported diabetes.<sup>4</sup>

#### Complications

- Heart Disease and stroke: In North Carolina, a previous history of heart attack, angina, coronary heart disease, or stroke occurred in 25.1% of adults with diabetes versus 8.5% of adults without diabetes in 2008.
- High Blood Pressure and Cholesterol: Among adults with diabetes, 68.8% had high blood pressure, and 65.6% had high blood cholesterol in 2007 in the state.
- Kidney Disease: 7.6% of North Carolina residents with diabetes had kidney disease in 2008 compared to 2.3% of general adult population.
- Visual Impairment and Diabetic Retinopathy: In North Carolina, more than 44 percent of adults (age 40+) with diabetes reported some visual impairment in 2006.<sup>5</sup> Recent research shows that diabetic retinopathy may be on the rise and one-third of all people with diabetes may have retinopathy.<sup>6</sup> More than 17 percent of NC adults with diabetes reported that diabetes affected their eyes or experienced diabetic retinopathy in 2008.



- Neuropathy: Neuropathy (inflammation and degeneration of peripheral nerves) is a common complication affecting 60 to 70 percent of patients with diabetes.
- Amputations: The NC Hospital Discharge data <sup>7</sup> shows that 2,608 lower limb amputations occurred among people with diabetes in 2007.
- Oral Health: In 2008, 17.5 percent of adults with diabetes reported that all of their permanent teeth have been removed because of tooth decay or gum disease, compared to 6.1 percent of NC residents without diabetes.
- Gestational Diabetes: NC Pregnancy Risk assessment Monitoring System (PRAMS) survey showed that 9.4 percent of all pregnant women in the state reported high blood sugar (diabetes) during the pregnancy in 2007.<sup>8</sup> Although gestational diabetes goes away after pregnancy in majority of cases, type 2 diabetes develops in 20 percent to 50 percent of women in the next five to 10 years.

#### Hospitalizations

- In 2007, diabetes was the primary diagnosis in 16,946 hospital discharges i with more than \$279 million in total charges in North Carolina. The number of hospital discharges due to diabetes either as a primary or secondary diagnosis was 37,596, and accounts for 3.8% of all hospitalizations (due to any cause) in the state.
- Diabetes was mentioned as a contributing condition in almost one out of every five hospitalizations in 2007.<sup>9</sup>

#### Costs

 The American Diabetes Association (ADA) estimated that the cost of diabetes for people in North Carolina in 2006 was \$5.3 billion. This estimate includes excess medical costs of \$3.6 billion attributed to diabetes, and lost productivity valued at \$1.7 billion.

#### Mortality

 Diabetes ranked as the 7th leading cause of death in North Carolina for 2007, accounting for 2,150 deaths (2.8% of all deaths) (primary diagnosis). <sup>10</sup> This represents a 10 percent increase in the number of deaths since 1998. Diabetes contributed for another 6.226 deaths in NC in 2007.

- North Carolinians who died due to diabetes lost an average of 8.5 years of life due to early death, and a total of 18,251 years
  of life in 2007.
- The age-adjusted diabetes death rate among African Americans (47.8 per 100,000 population) was 2.6 times more compared to whites (18.2 per 100,000).

#### **Diabetes Management**

 North Carolina has met the Healthy People 2010 goal for HbA1c test, annual medical foot exams and annual flu vaccine among North Carolinians with diabetes.

#### LCIF Coordinator Report Council of Governors MD 31 February 6, 2010 Asheville, NC

As I have read the updates of what our Lions are doing in Haiti, it makes me proud to be a Lion. As I write this report, Lions Hope for Haiti has mobilized more than \$1.8 million to date. This is not just money being sent to LCIF and a check written, but it is local Lions as well as Lions from other countries on the ground helping where they can.

LCIF has produced a video that can be seen on the www.lionsclubs.org website. Our current LCIF Chairperson, IPP Al Brandel, is seen on the video speaking to Lions volunteers in their Lions vests and caps. Forty of these Lions were from the Dominican Republic. He told them "When they see the Lions logo, they are going to see food, water and medicine coming." On this same video, PID Carlos Justiniano from Puerto Rico is also seen lending a hand and giving encouragement.

Supplies of food, water, and medicine have been delivered. LCIF is partnering with the Lions of Sweden to provide 200 large tents for housing the homeless and relief workers.

Immediate needs are being served as best they can. However, this will be an ongoing need for years to come.

Many of our individual Lions, districts and clubs have already made monetary contributions. I am aware of District 31E collecting almost \$1,700 from clubs and individuals during their recent Mid-Winter Convention. I know the district also contributed an additional \$1,000. In District 31G, the Golden Corral in Garner, managed by Lion Allan Michael, will host a fundraiser for Haiti on February 15. I am sure there are many other special donations that have been made.
