Council Chairperson Martha Butler called the meeting to order at 9: 00 AM.

District Governor Bob Roland gave the Invocation and District Governor Mike Flora led the Pledge of Allegiance.

For the record, the Council met in caucus on Friday evening, Feb. 9, 2007. Eight District Governors and all nine Vice District Governors were present at the caucus and at this Council Meeting. District Governor Morris Van Vleet, D31-E, was recovering from pneumonia and could not attend.

CC Butler welcomed all Lions and Guests and invited comments from Past International Director Lacy Presnell.

Presnell stated that PID Sid Scruggs and Judy sent their regrets as they were serving at a convention in England. Concerning the campaign for Second Vice President, Scruggs is still in the running, with two other candidates; Scott Storm of Connecticut and Joe Peterson of Arizona. Presnell will meet with the Promotions committee this afternoon to outline the necessary activities in this next year's campaign.

Kelly was asked to serve as Parliamentarian.

Covington moved to approve the Meeting Agenda; seconded by Kelly. Motion passed.

Flora moved to accept the Minutes of the November 11, 2006 Council Meeting; seconded by Leathers. Motion passed.

Council Secretary-Treasurer George Ohm read two communications from Lions Clubs International, stating that The University City Lions Club in D31-C and Greenville-Martinborough Lions Club in D31-H had both disbanded.

Ohm continued with the February Financial Report. All first half dues had been paid. The January 1, 2007 membership totals were received from LCI on January 30<sup>th</sup>. Invoices for second half dues were mailed and dues already received from Districts 31-B and 31-G. Ohm pointed out that the line item for Youth Exchange funds were short of the budget. It was understood that

each district would contribute \$500 to the Youth Exchange program; however, only seven of nine districts have made contributions to date. (See Attachment "A")

Holston moved to make up the deficit of the Youth Exchange Line item with Council Contingency funds; seconded by Covington. Motion carried.

Covington moved to accept the Treasurer's report: seconded by Kelly. Motion carried.

CC Butler reported the new Lions Clubs International Policy for Past Due Club Accounts in excess of \$20 per member or \$1000 per club that is outstanding for 150 days or more, stating that said clubs will be automatically suspended, including their charter, privileges and obligations for up to 90 days. If the club does not pay the entire amount within the 90 days the charter will be cancelled.

An account has been established and the Council now has access to telephone conferencing. Butler will advise each Governor on how to access the account.

LCIF has dispensed grants to districts 31-A for the McCune Center, D31-B for a medical mission, and D31-F for disaster relief.

North Carolina Lions Foundation President, Ron Staley reported that the Shaw Brown building was demolished and the site cleared for the new Bill and Donna Udovich Dormitory. To date the Foundation has received \$390,000 in cash and pledges toward the construction of the building. Applications have been made to LCIF for a \$75,000 grant and for a \$50,000 grant from the Cannon Foundation. Staley described the numerous services performed by the Foundation this year. Camp Dogwood staff is preparing for summer camp and is asking for volunteers to serve during the camping season. At least 4 volunteers are needed per week. Properties committee has identified numerous items for Volunteers week, April 16<sup>th</sup>. White Cane and Camp Dogwood Ticket Sales are down from last year's totals.

Staley claimed that programs and services have increased by 20% over the last several years. He indicated that during this time White Cane donations have been relatively flat; he estimated that we would need an extra \$100 per club or \$4.00 per member to meet our goals. The Camp Dogwood committee has adopted a banner patch for all clubs meeting the sales of 3 books per member. (See attachment "B")

Staley expressed the best wishes from PDG Bill and Donna Udovich, and he asked for prayers for their recovery.

NCLF Executive Director, Steve Walker, stated that LCIF has been very helpful in the grant application process. Surveying the membership list he found that 36% of the Lions in North Carolina have been Lions less than 5 years indicating a goodly number of relatively new Lions who need information about Lionism. In 2002 we gained 800 new Lions however by 2006 we only had 400 left. With better understanding of our mission we may keep more Lions. The NCLF Speakers Bureau is an attempt to get the word out to new Lions. He is expecting each speaker to give 6 to 10 programs per year.

2007 State Convention Chair, PDG Joe Silvers, reported on the progress of the 2007 State Convention in Asheville. He still needs ad sales. The Golf Tournament will be held on Friday, June 1<sup>st</sup> at the Broadmore Golf Club. Fees are \$45.00. The Renaissance Hotel has been fully

booked, with over flow housing now directed to the Best Western across the street. The Convention theme will be Patriotism to show support for all of our military both active duty and veterans. A silent auction will be held on Friday with proceeds going to the International Officers Campaign fund. (See attachment "C")

Kelly moved to approve the State Convention Report; seconded by O'Malley. Motion passed.

Kelly moved to approve the State Convention Committee Chairpersons; seconded by O'Malley. Motion passed.

State Convention Chairperson, Gwen White, also a member of the 2007 Convention committee, congratulated Silvers, Gasperson, and District 31-A for their efforts in planning the Convention and raising \$66,000 to date. White went on to state that, due to seating limitations for the District Governor's Banquet, it was planned to limit the head table seating to one tier, with VDGs and the International family seated at floor level round tables. The Saturday morning General Session will be limited in reports to allow scheduling a Town Hall Meeting with the visiting 2nd Vice President, Al Brandel. Seminars will be held in the afternoon. The Peace poster and Environmental Photo winners will be presented on Sunday. Mrs. North Carolina, Kylee Odom, will also speak at the Convention. First timers will be recognized with a special ribbon.

PDG Paul Bledsoe, Chairperson of the 2008 State Convention, announced that the 2008 State Convention will be held in Greensboro at the Airport Marriott Hotel. Room rates will be \$89 per night with unlimited free parking. The Winston-Salem Host Lions Club will serve as the Host Club. The Hotel has been very co-operative and will provide 14 complementary rooms and up to 40 exhibit tables at no charge.

Covington moved to approve the Greensboro Airport Marriott as the location for the 2008 State Convention; seconded by Holston. Motion carried.

For the 2009 Convention, 31-F investigated a hotel in Pinehurst; however, after rooms were quoted at \$203 per night, this was eliminated. PDG Ron Staley is checking on the new Convention Center near Lowes Motor Speedway. White advised the Council that the state is now at a crossroads, we are too small for large hotels and too large for small hotels. The days of hotel rooms under \$100 are nearly over. The Council and subsequent Councils may have to consider alternative convention formats in the future.

PDG Ralph Hester, NCLF Clinical Eye Research Chair, suggested that we invite representatives from Wake Forest University to speak at the Convention. Butler suggested that Hester confer with Holston and White for a spot on the program.

Mrs. North Carolina, Kylee Odom, announced that she was named the executive State Director for the Miss North Carolina Pageant and was influential in bringing the State Pageant to Asheville in April 18-19, 2007. She reported on her daughter's progress and expressed her sincere appreciation for all of the help from the Lions of the state. Odom stated that her history goes back to when she was a Leo and had danced at some of the D31-A Conventions.

#### Old Business

1. The Bid to Host the 2012 USA/Canada Forum was an agenda item, however there was no information available, so the topic was tabled.

2. MD31 State Redistricting Plan as proposed by the Long Range Planning Committee was discussed at length during the caucus.

Roland moved to reject the Six District Redistricting Plan; seconded by Leathers. Motion passed.

As an alternative, an eight district plan was proposed to the Governors during the caucus which involved the disbanding of District 31-C. The Council will study the proposal and bring it back to the Lions at a later date.

3. PDG Paul Bledsoe reported upon the NC Lions Disaster Recovery Partnership with NC Division of Emergency Management. Plans through 2007 include free on-line classes for FEMA Certification. Once the courses are completed, the individuals are eligible to sign up for reservist training. The intention of Lions involvement will be to aid Disaster Recovery Teams on guiding individuals through the Emergency Management System after disasters. (See Attachment "F")

#### Council Committee Reports

Constitution And By-Laws. Chair Dave Butler reported that a survey of the Constitution and By-Laws indicated that we must make the wording more gender friendly and to conform to the International Association of Lions Clubs Constitution. The Committee proposed to revise the Constitution and By-Laws to make all references to gender his/her or chair persons as applicable.

Holston moved to approve the Committee suggestion to make the Constitution and By-Laws gender neutral as stated; seconded by Kelly. Motion passed.

Butler stated that the committee will continue to study the State Constitution and By-Laws for further revisions and make proposals as needed in the '2007-2008' Lionistic year.

MD31 Lions Policy and Procedures Manual. With the combined efforts of the Constitution and By-Laws and the Long Range Planning Committees, a new Policy and Procedures Manual was prepared for the Council's consideration. The Manual brings together several policies and agreements which will help clarify policies and procedures of the State Council. The Manual, and any subsequent revisions, is designed to be approved by the Council of Governors at the next official meeting after presentation. Several corrections were suggested during the caucus that will be included in the final draft. (See Attachment "G")

Holston moved to accept the Policy and Procedures manual as edited and to be voted upon at the May Council Meeting; seconded by Covington. Motion passed.

Extension. Chair PDG Houston Henderson, reported that the Extension Workshop held in D31-A, resulted in forming 4 new Lions Clubs. The LCI sponsored Extension Team of John and Wanda Barnett of Arkansas, Mike Gayda from Washington State and Natalie Kenny from LCI conducted the 3 day workshop of classes and actual calls on prospects. Districts H&J will hold a joint workshop in March. (See Attachment "H")

Holston made a motion to allow each district to apply for matching funds of up to \$500 from the Council MERL Committee allowances and the Contingency fund, to conduct Extension Workshops within their district. The motion was seconded by Roland. Motion carried.

Diabetes. Chair Bill Barnwell distributed copies of a NY times article describing a Wake up Call for Diabetes awareness. Individuals with pre-diabetes can reduce their risk by reducing calories by 450 calories per day and exercising to use up excess insulin produced by the body. Any screening for Diabetes must be done after fasting to insure accurate results. Surveys indicate that many fear blindness over death. (See Attachment "I")

Information Technology. Chair Michael Schwartz. The committee is preparing an internet directory of Clubs, websites and webmasters. They are working with the Public information and education committee to develop a new state website. The committee also presented a policy proposal for internet use, perhaps as an addition to the Policy and Procedures Manual. PID Sid Scruggs also has a new website; [www.sidscruggs.com](http://www.sidscruggs.com). PDG Gene Everette commented that he has found bogus websites associated with Lions. (See attachment "J")

Holston moved to have the Constitution and By-laws Committee study the Internet Proposal for possible addition to the Policy and Procedures Manual; seconded by Roland. Motion Passed.

Leadership. Chair Bob Shook reported that the MERL Team attended 6 of the 7 District Conventions to conduct seminars. He urged District Governors to begin planning workshops for training of incoming club officers and Region and Zone Chairpersons. LCI has increased the emphasized of Zone Chairpersons in Lionism. The Southeastern Leadership Workshop will be held in Florida. The deadline for applications is March 16, 2007. Vice District Governor candidates should plan to attend the workshop. VDG elect training will be May 11 – 12, 2007. (See Attachment "K")

Historian. Chair Diane Whitley submitted a report requesting that Clubs and individuals submit histories by March 28, 2007. A brochure was supplied showing an example of the histories desired as well as an order form for books. (See Attachment "L")

Liberty Day. Chair Jim Edmund announced that the Liberty day celebration will be held on Friday, March 30 at Northeastern High School in Elizabeth City, NC. Rooms had been reserved for Lions at the Holiday Inn at \$75.00 per night for those who wish to come in early. (See Attachment "M")

Leo Clubs. Chair PDG Paul Smith stated that the Leo State Convention will be held at Camp Dogwood on March 30-31. Rooms will be offered at half cost to encourage more attendees. Election of the state President will be on the agenda. (See Attachment "N")

Membership. Chair PDG Gene Everette suggested that we have a reality check of our clubs. The first half of this year we gained 475 new members, hopefully we will retain these new Lions. Everette pointed out that the baby boomers make up 60% of total volunteers. We need to ask more baby boomers to join our Clubs. (See Attachment "O")

Nominations. Chair Allen Deaton reported that District 31-F is the only a full district in MD31 and they have elected Tommy Brooks as District Governor for 2007-08 and David Martin as Vice District Governor. Districts A and G are also able to elect District Governors this year. All other districts must submit names of elected Governors to Lions Clubs International for approval. The Council of Governors has passed a unanimous resolution to endorse PID Sid Scruggs for 2<sup>nd</sup> Vice President of Lions Clubs International. (See Attachment "P")

Youth Exchange. Karen Littlefield submitted a report stating that she has 8 outbound students going overseas and 10 inbound students that will visit North Carolina. The visiting students will be staying at the outer banks during July 10-14 and at Kure Beach July 14- 21. The complete schedule is posted on the website; [www.yenorthcarolinausa.com](http://www.yenorthcarolinausa.com) She is still looking for host families for 10 day stays. (See Attachment "Q")

Kelly moved to approve the Council Committee Reports; seconded by Leathers. Motion Passed.

Sight First II Sector Coordinator PCC Harvey Whitley submitted a report for the Council. He stated that USA Coordinators requested the videos be modified to reflect use of NCLF funds in the United States as well as overseas. USA specific resources have been added to the CSFII home page at the [www.lionsclubs.org](http://www.lionsclubs.org). (See attachment "R")

The Governors voted to designate the Tail Twister funds raised at the State Convention to used for Campaign Sight First II, equally divided to each of the nine Districts.

Meeting adjourned at 11:50 AM.

### **NCLF President's Report to the Council of Governors**

February 10, 2006

Council Chair Martha, Governors, Vice Governors, Lions and guests:

I am pleased to report that we continue to have another busy year. Preparations for construction of the new Udovich building are underway. The Shaw Brown building has been burned and the debris is being removed. We have currently received about \$390,000 towards construction of the building and grant requests totaling \$125,000 have been submitted to LCIF and the Canon Foundation. We will hear from those requests sometime this spring. So far this year your Foundation has provided 765 Mobility Canes, 144 free Hearing Aides, and has provided 708 Eye Exams and 1033 pairs of Eyeglasses through Matching Funds. The Vision Van has been to 76 Eye Screenings sponsored by clubs across the state and has screened 4,158 individuals.

Preparations for summer camp at Camp Dogwood are underway. We are currently reviewing applications almost daily from persons wishing to work as camp counselors. We continue to need Lion volunteers for the Camp and need to get the word out to our members that there is a continuing need for their services during the camping season. Camp Director Sandy says we need four volunteers each week. We also need to make all the Visually Impaired in our state aware that the Camp is available. Even though we have fewer rooms this summer because of our construction project, there will still be plenty of opportunity for persons to attend the camp if they don't all want to come the same week. Personally I would like to see more camper applications for the camping season. Even though we continue to have more applications than we can accept, it is difficult to get enough campers to fill certain weeks of the camping season.

The Properties Committee and Volunteers Committee met last Saturday at Camp Dogwood and began planning for the April Volunteer Week. There is a long list of items that we need the Volunteers to address and we look forward to having everyone who is willing and able to work come to the camp the week of April 16 to get the Camp ready for this year's camping season.

Although there was a lot of energy and excitement in the districts around our White Cane drive and the Camp Dogwood Raffle, contributions from both of these programs are down. At the end of January, White Cane contributions were down over 15% from last year's levels and Camp Dogwood ticket sales were down about 8%. Attached is a copy of these reports. You will see them again tomorrow. I plan to email you copies going forward. I hope you can find room in your newsletters for your district's report.

Although I don't see any reason to panic, I must admit the numbers make me uncomfortable since we're well into February. Please go back and ask all of your clubs and district leaders to emphasize White Cane and the Camp Dogwood Raffle. Recently the Vice Governors and a club I was visiting asked me how much was needed for White Cane. As you know our programs have increased about 20% over the past years. Our White Cane contributions during this period have been basically flat. The majority of that increase has been Matching Funds requests, money that goes directly into services



we provide in our communities. As I see it, if we are to meet the needs of our clubs, and not cut our statewide programs, our White Cane needs to increase and that increase needs to be about \$100 per club. That is about \$4.00 per member. I don't think that this is an unreasonable expectation especially when you consider the alternative. I think as leaders we should be willing to give our Lions this message. This is also a goal we should expect when we have our Budget Hearing in April.

This month we are holding a planning session at the Camp to look at what we can do to utilize Camp Dogwood during the months there is no camp for the visually impaired. I feel this is something that has been missing. The group of Lions meeting at the camp is being chaired by PDG John Miller. Past Foundation President Neil Alexander has agreed to facilitate the meeting. I feel that with John's leadership, we should be able to come up with a plan and strategy that can be implemented over the next several years.

Again I want to encourage each of you to remind your District Committee Chairs to attend state committee meetings. I think our committees are making a lot of progress, but attendance is still not at a level we need and should expect. The telephone conferencing system for our Foundation Committee State Chairs has been installed and is available. It is simple to use and instructions have gone to all the NCLF State Committee Chairs. Some Committee Chairs are starting to use it. I think it is now a matter of emphasizing that it's available and reinforcing the availability of this tool to our District Committee Chairs.

[ I do have one item for your consideration at this morning's meeting. It has been suggested that the banner patches we plan to present to clubs which sell three books per member be available so the Governors can present them at each District's award banquet. I think this is an excellent idea and the Camp Dogwood Committee supports the idea. I only need to know if this is what the Council of Governors would like to do. If so, we will arrange for the banner patches to be given to each Governor prior to your awards banquet.

I thank you again for your support. It is great having this opportunity to serve with you. With your leadership and the help of our Lions Clubs we look forward to meeting the needs of those we serve.

With geographic locales of clubs throughout the 100 counties of NC, North Carolina Lions will become an integral part of emergency management outreach and recovery assistance in each community for which they live and work.

### **Phase One**

#### **NCDEM Activities Planned with NC Lions through April 2007**

- 5) After completion of courses, NC Lions should contact their Governor and relay to them that they have the certification. The governor then should compile a list of Lions in their districts.

After list is completed, the NCDEM IA staff will determine the best training localities for "Reservist Training" throughout the state. The hopeful date for the classes to begin is the 3rd or 4th week of March 2007.

*My recommendation is that the DG, VDG or someone appointed by the DG be a District Lions EM Coordinator. It would make it easier for us to accomplish our endeavors.*

- 6) In the next couple of weeks each Governor will receive a list of Emergency Managers by County. We will inform them along with the NCDEM about our partnership, and find specific needs and integration within each county. More to follow on this correspondence.

- 7) Overview of our alliance...

*Individual assistance after disasters. Lions will help as floaters to assist the team with giving individual guidance upon their entrance to Disaster Recovery Centers.*

*Lions will interview individuals and help with exit interviews with guidance and training from NCDEM Individual Assistance Manager .*

*Lions will offer disaster preparedness education with the VIP's, handicapped and senior citizens throughout the state with information and seminars under the umbrella of various state organizations and councils such as the NC Council of Aging and Adult Services.*

*Long Term Recovery Teams to assist the continued support and care of disaster victims with provisions and education training set forth by NCDEM Management Team.*

*In smaller natural disasters, Lions would be the link for care provided by the NC Division of Emergency Management. A network of Lions in locations throughout the state will contact and assist in the care of victims under the supervision of the NCDEM.*

*Lions will assist disaster victims in the education, and at Disaster Recovery Centers help victims with the filling out of forms necessary for relief benefits for individual victims. Lions will be certified in the form of assisting individuals with SBA applications and certification with FEMA guidelines for ICS.*

## **“Uniform Allowance VDG/DG, Council Chairperson, and State Secretary/Treasurer”**

Uniform allowance for VDG/DG, Council Chairperson, and State Secretary- Treasurer shall be as follows:

1. Vice District Governors will determine their Official Blazer, pants, etc. prior to the start of their year as Vice District Governor. This uniform will be worn for both their Vice District Governor year and their year as District Governor. There will be an allowance of \$130.00 provided from the State Council Administrative Fund to help with the purchase of the Official Uniform.
2. An allowance of \$130.00 will be provided, from the State Council Administrative Fund, to the elected State Council Chairperson to help with the purchase of the Official Uniform to be worn during the year he/she will serve as Council Chairperson. The Council Chairperson uniform will match, as close as possible, the other members of the Council of Governors.
3. An allowance of \$130.00 will be provided, from the State Council Administrative Fund, to the elected State Secretary-Treasurer, to help with the purchase of the Official Uniform to be worn during the time he/she will serve as State Secretary/Treasurer. If State Secretary/Treasurer is reelected to a 2<sup>nd</sup> term, and the uniform does not change, the allowance will cover 2 years as it does for the Vice District Governor/District Governor's years. The State Secretary-Treasurer uniform will match, as close as possible, the Council of Governor's uniform.

## **“State Council Chairperson Selection Procedure”**

Past District Governors interested in the position of Council Chairperson shall submit their name and resume of service by December 31<sup>st</sup> to the State Council Secretary/Treasurer. After certifying qualifications, the names and copies of resumes are to be submitted to the currently serving Vice District Governors no later than January 20<sup>th</sup>.

The currently serving Vice District Governors will interview each candidate and make their selection by the majority of a secret ballot. One Vice District Governor shall act as spokesperson for the group during these interviews.

## **“State Secretary/Treasurer Selection Process”**

State Constitution, Article V, Section 2 States:

The New State council shall elect a State council Secretary-Treasurer, who in the discretion of the State Council, may be other than a State council member, to a one-year term. No Lion may serve as State Council Secretary-Treasurer for more than five (5) consecutive one-year terms. The new State Council may, at its discretion, consult with the outgoing State Council concerning the performance of that Council’s Secretary-Treasurer in considering the election of the Secretary-Treasurer for the new State Council.

1. Any active Lion interested in the position of State Secretary-Treasurer shall submit their name and resume of service to each currently serving Vice District Governors by December 31<sup>st</sup> (received by December 31).
2. The currently serving Vice District Governors will review these resumes, conduct interviews, and make their selection by the majority of a secret ballot. One Vice District Governor shall act as spokesperson for the group during these interviews.
3. The selection of the State Secretary-Treasurer shall be made at the February State Council Meeting.

## DIABETES AWARENESS

Wake up, Pre-diabetes, do you have it? 41 millions people in the United States have pre-diabetes. Pre-diabetes is the forerunner of type two diabetes. Many of the people with pre-diabetes will develop diabetes within 10 years. We also have a greater risk of a heart attack or stroke even if type two diabetes does not develop.

Again I suggest if we have pre-diabetes, that we eat 450 calories less of food each day which will help us loss 5 to 7 percent of ur body weight. Exercise will also help us use the available insulin.

By weight loss, exercise, and eating healthy we will be able to reduce our risk by 58 per cent.

If you are over 45years and over weight, you should be tested. Ask for a fasting glucose test. The most important word here is fasting. We need to fast for at least 8 hours prior to your test and it needs to be taken by a competent lab. Any reading much higher 100 mg/dL is consider pre-diabetic.

### Diabetic Adults Fear Blindness More Than Death

Adults with diabetes fear blindness or uncorrectable vision loss more than any other diabetes-related complication including premature death, according to results from a survey commissioned by the Lions Clubs International Foundation (LCIF) and Eli Lilly and Company.

Many diabetes patients feel they have been or would be affected by emotional challenges due to vision loss or blindness as a result of diabetes. At least 40 percent of adults with diabetes in the countries surveyed cited vision loss - including significant problems not correctable with glasses or contact lenses, or blindness as what they feared the most; a substantially smaller proportion (8 to 20 percent) cited premature death as their greatest fear. The survey also found that people with diabetes fear blindness or vision loss at least twice as much as certain other health complications.

The seven-country survey, presented during the International Diabetes Foundation's 19th World Diabetes Congress in December in Cape Town, South Africa, involved telephone interviews with more than 1,450 adults with diabetes from the United States, France, Italy, Germany, South Africa, Spain and the United Kingdom. Diabetes is the leading cause of blindness in working age adults in the United States and a leading cause of blindness worldwide. Millions of adults with diabetes have diabetic retinopathy, a condition of the eyes that can lead to blindness. Only half of adults with diabetes in the countries surveyed were aware that blindness is a potential complication of diabetes. Adults with diabetes also associated vision loss with emotional issues including feelings of frustration, loss of independence, depression, loss of self-confidence and a strained relationship with a spouse or partner.

"I believe adults with diabetes fear vision loss and its potential effect on their emotional well being, independence and overall quality of life," said LCIF Chairperson Ashok Mehta. "Given the devastating effects of vision loss, we must continue to raise awareness of preventive measures people with diabetes can take to delay or prevent this serious disease complication, such as seeking annual dilated eye exams."

Knowledge of diabetes complications, including poor circulation, kidney damage, vision loss, blindness, heart attack, sores and premature death, varied. Some survey participants were highly knowledgeable about diabetes complications, while others were only partially informed.

Additionally, many but not all people with diabetes were aware that blindness is a complication of diabetes. Survey participants also cited poor circulation in their hands and feet, significant vision loss or blindness as complications associated with diabetes.

Among survey participants who are not blind, more than 80 percent acknowledge that it is important to have regular dilated eye exams to check for diabetic eye disease and a large majority also gets dilated eye exams at least once a year.

"We are encouraged that people with diabetes are willing to take proactive measures to preserve their vision. Our goal moving forward is to ensure that as many people with diabetes as possible take these steps to preserve their vision," said Dr. Donald Fong, an assistant clinical professor of ophthalmology at the UCLA School of Medicine who collaborated on the survey.

According to the American Diabetes Association, more than 20 million people in the United States, or seven percent of the population, have diabetes. While an estimated 14.6 million have been diagnosed, another 6.2 million people remain undiagnosed and have an increased risk of developing diabetes-related complications.

More than \$22 billion is spent annually on care and services for people who suffer from vision loss. People with diabetes are 25 times more likely to suffer from vision loss than the rest of the population, and the longer a person has diabetes, the greater the risk for retinopathy. With early detection and timely treatment, most vision loss can be avoided. It is this group of people that Lions need to reach with sight-saving information through the Lions Eye Health Program (LEHP).

Lions developed the program to promote awareness of eye health and educate people who are at risk for eye disease. The program was designed to increase early detection and timely treatment of glaucoma and diabetic retinopathy. Through LEHP, Lions clubs, community organizations and individuals are able to promote healthy vision in the United States. To increase public awareness, Lions can distribute eye health information, sponsor informational seminars and conduct eye screening to encourage annual dilated eye exams. The program is made possible through grants from LCIF, Eli Lilly and Company, and Allergan. # The North Carolina Lions Constitution & Bylaws

## Web Site Administration & Policies

### Proposed

Using the World Wide Web is strongly encouraged in that it provides the Lions of North Carolina with a powerful tool to convey information quickly and efficiently on a broad range of topics relating to its activities, objectives, policies and programs.

**Section 1:** Each Web site shall have a clearly defined purpose that supports the mission of the International Association of Lions Clubs, the Lions of North Carolina and its respective districts and local subordinate clubs. The district governor, club president, or his/her designee in accordance with official policies, shall approve the defined purpose and general content of the Web site.

- (a) Use of the name, goodwill, emblem and other logos of the association shall be according to the guidelines established in the by-laws of the International Association of Lions Clubs.
- (b) The Web site must abide by all laws regarding copyrights, trademarks, and other intellectual property.
- (c) Non-copyrighted material, text, clip art, hypertext links, images and sound or video clips may be used only if they directly relate to the association's mission.
- (d) The Web site shall not contain any advertisements or commercial endorsements, except those for which the association, state, district or club have approved and are deemed appropriate.
- (e) The Web site shall not engage in the electronic sale of merchandise, merchandise commissioned by the association, or competing products, without the approval of the association, state, district or subordinate clubs.
- (f) The Web site shall not contain any links direct to any sites that contain material that is not appropriate to the mission of the association.

**Section 2:** For the purpose of preventing duplication on the Web, a Web site shall normally be limited only to information for which the establishing organization is responsible.

**Section 3:** Consistent with other leadership responsibilities for public and internal communication, the decision whether or not to establish a Web site, and to publish appropriate information that supports the mission of the International Association of Lions Clubs, the Lions of North Carolina and its respective districts and local subordinate clubs, falls to the district governor, club president, or his/her designee.

- (a) No individual member may own the rights to a Web site.
- (b) Passwords or other identifying user names shall be maintained by the organization, its respective districts or local subordinate club.
- (c) The Web site should include an email contact address for reaching the person managing the site, so visitors can report any problems or concerns.

**Section 4:** Editorial control of a Web site's contents shall be the responsibility of the organization.

- (a) The contents of a Web site must be periodically updated and maintained.
- (b) A Web site that no longer provides accurate information about the organization, its leadership, programs or services, shall be discontinued and removed from the World Wide Web within a reasonable period of time.

Saturday, February 10, 2007



LCIF/Campaign SightFirst II  
Report to MD 31 Council of Governors  
Asheville, NC  
February 10, 2007

Since my report to you last November, we have been able to secure commitments from Lions to serve as District Coordinators for 31 A, 31C, and 3 ID. We are still in need of more Group Coordinators in these districts who are willing to assist us with presenting the Campaign SightFirst II program at the club level.

I reported to you last time that I would be attending a SightFirst leadership meeting in Oakbrook during the month of December. The purpose of the meeting was to brainstorm about where we are as we reach the halfway point of the Campaign. Many ideas were shared and actions have been taken to supply us with more resources.

We shared at the meeting that one of the complaints we hear from Lions here in the United States is that most of the money from SightFirst goes out of the US. That perception has not been helped by the media we are using to promote the campaign as it portrays mostly non-US individuals receiving help. We requested more USA specific documents to promote the campaign. These have been delivered as of this week. Now on the lionsclubs.org web site under CSF II home page is a link to USA Resources. By clicking there you can access the following:

All these things were in response to our specific requests for help. I have not had the opportunity to review all these materials yet, but they will no doubt be helpful in our presentations of the world's largest and most effective humanitarian campaign ever conducted.

Another thing that was suggested at our meeting was to have a "halftime" meeting in our sectors to see how we are doing and how we are going to be able to complete our goals this year and next. Several multiples have already held their meetings and they have been fruitful.

Our "halftime" meeting here in North Carolina is going to take place on Saturday, March 3, 2007, at the Governor Morehead School in Raleigh from 10:00am until 3:00pm. Lodging for those who choose to come early and spend Friday night will be provided at the Velvet cloak Inn nearby. The lodging expense will be covered by LC1. An e-mail invitation will be sent out this coming week to **all District Coordinators, District Governors, and Vice District Governors.** The meeting will be jointly conducted by PCC Bill Filmore from Alabama, who is our SightFirst National/Multinational Coordinator for the Southeast, as well as me.

We will also be joined by Lion Rachel Beard who is our marketing expert from LCI. This is an extremely important event and I hope you will attend.

I appreciate the opportunities given to me this year to present programs at your Mid-winter and Fall Conventions. I was invited to 31A, 3 IE, 31GHJ. I was also invited to 31C but was unable to attend due to a conflict.

Here is where we stand as of February 8, 2007 in goals reported:

North Carolina	\$145,880
South Carolina	\$255,055
Florida	\$207,245
Puerto Rico	\$470,000
Georgia	\$156,195
Alabama	\$166,950

You will notice that we are last in goals reported. The main reason is we have only gotten reports from 6 of our 9 districts. It means our Coordinators are not reporting and our clubs do not know to send in Form RC-1. That concerns me and I need your help to change it (refer to the first paragraph of this report).

Our next big reporting date is coming up this month. On **February 26, 2007**, we will be having a worldwide report date where we will report known funds raised and updated goals. What that means is that each Group Coordinator makes five or six phone calls to the clubs he or she covers and reports the results to his or her District Coordinator. The reports are then given to me and I relay them to International. A very simple and efficient process, but it starts with the Group Coordinators at the club level. Do you see now why we need good Group Coordinators? They are basically just like your Zone Chairs. Imagine not having Zone Chairs.

Time is running short for us in this campaign. As of February 8, 2007, \$69,024,580 had been raised worldwide. That is about a third of our goal.

Thank you for your assistance. We cannot accomplish this goal without your support.
