Council Chairman, Brad Logsdon, called the February meeting of the 2005-06 North Carolina Lions Council to order.

District Governor Steve Wilson gave the Invocation followed by District Governor Michael Allman leading the Pledge of Allegiance.

For the record, the Council met in caucus on Friday evening, February 10. All nine District Governors, as well as six Vice District Governors, were present at the caucus. All district Governors and Vice District Governors were in attendance at the Saturday Council Meeting.

Bledsoe served as Parliamentarian.

CC Logsdon welcomed all Lions and Guests to the meeting and invited comments from Past International Directors.

Past International Director Sid Scruggs reported that Past International Director Ron Huber recently had hip replacement and would require extensive rehabilitation. He and Lion Jane would appreciate cards. His new address is:

Lion Ron L. Huber, PID 4502 Merlot Way Greensboro, NC 27410

Scruggs stated that he and Lion Judy would be attending the South Carolina District 32-A Convention at the request of District Governor Matt Jones. Scruggs will also represent the Lions of North Carolina at the UN Day in New York. Afterward, they will go on to Turkey for the Mission 30 conference. He suggested that the governors urge their Zone chairs to use the membership registers available on the LCI web site.

Scruggs announced that President Ashok Mehta would visit North Carolina on June 17th with plans being made for a dinner with him at the Sheraton Imperial Hotel in Raleigh.

SST George Ohm reported receipt of a thank you note from Andy McKean of Liberty Day for the \$500 donation to the National Liberty Day Foundation. Invoices for second half dues

were mailed, with payments already received from two districts. Ohm has two applications from Past District Governors for the 2006-2007 Council Chair Position. All districts have elected Vice District Governors. The IRS form 990, for Non Profit 501C4 organizations, has been sent to the IRS. The Treasurer's records for 2004-05 were sent to the CPA for the annual audit, with a report expected by the State Convention.

Ohm offered an addition to the **November 2006 Minutes**:

Page 4, Para. 8,a.

Add: "Council Chair Brad Logsdon, reported that LCI Legal Division's position was that "in the case of a conflict with the current Constitution", the current District Governors are to determine the selection process for the Council Chair position."

This statement clarifies and adds authority to the District Governors changing the selection process.

<u>Dupree moved to approve the amended minutes: seconded by Sandy. The motion passed.</u>

Ohm continued with the **February Financial Report**. He offered two reports, a balance sheet including the Council Account and the Promotions Account, and an itemized report for the Council. (See Attachment "A")

Mayes moved to approve the financial report; seconded by Dupree. Motion approved.

Foundation President Carlton Metts reported that camping season is around the corner.. Applications are being taken for campers, counselors and volunteers. White Cane and Camp Dogwood ticket sales are ahead of last year. Budget hearings will be April 7-8 with Volunteer Week staring the next week, April 10. The Jack Stickley Fellowship scrolling LCD display is up and running in the Lodge. The Foundation is scheduling a caucus this afternoon to discuss the plans for the new dormitory. An unnamed donor has pledged \$250,000 towards the building. (See Attachment "B")

Executive Director Steve Walker will be placing the last order for \$50 pavers for the **Sensory Garden.** Here after the price will increase. He also advised due to changes in the medical forms the camper application process is longer. He advised to assure those who may complain that the forms are being processed.

PCC Harvey Whitley was recognized to speak on **Campaign Sight First II**. He completed this training at Oak Brook. All district coordinators have been named. Three four-hour training sessions are scheduled for March 11, 18, and 26. Sites will be at Camp Dogwood, Archdale, and Greenville. Completed reports must be made to Dr T.S. Lee on June 14. Clubs will be asked to raise funds through personal pledges over 3 years, outside solicitation, special fund raising, and finally club treasuries. Goals are at least \$125 per member. Model clubs have pledged \$400 per member. Donations of \$1000 each are eligible for Melvin Jones Fellowships. There are plans to have a Sight First II information table at the State Convention and a seminar on Saturday afternoon. (See Attachment "C")

PDG John Miller reported on **Services for the Blind**. He reported that the Teaching program to teach teachers for Visually Impaired students has been floundering for the last few years. The Commission voted to urge legislators to move the school to another facility. However, renewed interest has strengthened the program at UNC Central.

Referring to Hurricane Katrina relief, Miller stated that all of the costs of his trips to the disaster area were covered by the generosity of the Lions of North Carolina. Miller commented that it was suggested that the Lions should consider preparing a disaster relief plan. He offered to serve on an Ad Hoc committee to this end.

PCC Diane Whitley requested an advance of \$60.00 from the Council for preparing the Lions Logo for the NC License plates.

Wilson moved to advance \$60.00 to Whitley to allow preparation of camera-ready logos for the License plate project; seconded by Allman. Motion passed.

Council Chair Logsdon commented that North Carolina did not receive any of the \$20,000. Promotional Grants applied for. Only three grants were issued in the United States. He was encouraged to re-submit the applications with the hope that more funds may be made available. The Governors applied for matching grants of \$1500 for local advertising. To date three districts were approved.

PDG David Boyd gave his report on the 2006 State convention. The state convention needs advertising dollars to help defray the cost of the convention. He outlined the daily schedules of the convention. He questioned if the Governors wished to have a silent auction on Friday Evening. He asked for Districts and Governors to gather door prizes and auction items. Seminars will include Campaign Sight First II and a Question and Answer session with Vice President Jimmy Ross.

Scruggs asked about plans for pick-up of Ross. It was suggested that all District Governors be in the welcoming party. Boyd and Logsdon stated that this would be addressed at the next convention committee meeting. Ohm noted that the Council voted in November to fund the Media Center for the Convention. Ohm was directed to issue the \$4000 budgeted advance to the Convention Committee. (See attachment "D")

Gwen White presented the plans for the 2007 State Convention, to be held at the Asheville Renaissance Hotel on May 31-June 3, 2007. Menus and prices will be available for the August 2006 Council Meeting. PDG Joe Silvers has a committee of 40 plus lions. In an effort to reduce costs to Lions, the committee is attempting to find sponsors for Friday Fun Night and the Tail twisters Breakfast. Tours are planned for the Biltmore house, Harrods in Cherokee and local shopping. Expected Vice President Al Brandel has been invited as guest Speaker.

The 2008 State Convention is planned for Greensboro the end of June 2008. DG Paul Bledsoe will serve as Chairman. Scruggs has arranged for the sitting Lions President Mahendra Amarasuriya to be the keynote speaker.

Logsdon called for a 20-minute recess.

Logsdon resumed the meeting and called for Statewide Committee Reports.

Boys An Girls Home Chair Logsdon reported that there was a fire in the laundry dryer causing considerable smoke damage to the Lions Cottage. Unfortunately, this incident has accelerated their remodeling schedule, so now the cottage will have to be completely remodeled before the boys are allowed to return. The total cost of the renovations is estimated at \$47,545. In addition the home needs to replace the 15-passenger van that will no longer meet insurance requirements. Lions may be asked to volunteer a workday to help spruce up the cottage grounds. (See attachment "E")

<u>PDG Martha Butler gave a report on District 31-A's Eliada Homes</u>. Substantial improvements and renovations have been completed on the Lions Cottage. The cottage houses 9 children in the ages of 12 through 17, and has a waiting list of over ten children. Most children are eventually reunited with their families. Tours are available every Tuesday for interested Lions. Eliada's mission is "Helping Children Succeed" (See attachment "F")

<u>Constitution and By-Laws Chair PDG Ron Kelly</u> presented changes to the State Constitution regarding the Council Chair selection Process.

- A. Multiple District Constitution, Article V, State Council, Section 1. Revise the last sentence to read:
 - "Consideration may also be given to any active Past District Governor who has not served as Council Chairperson."
- B. By-Laws Article 1, section 7. Revises the final day to submit résumé's to December 31, and the State Council Secretary/Treasurer is to send the qualified résumé's to the serving Vice District Governors by January 20.

Dupree moved to accept the changes as presented; seconded by Wilson. Motion Passed.

C. By-Laws Article III, Section 9, Nominating Committee. Recommends adding the duties of assisting District Governors in seeking qualified Past District Governors for the position of State Council Chairperson.

Allman moved to accept this addition to the Nominating Committee; seconded by Mayes. Motion Passed.

<u>Diabetes Awareness Chair William Barnwell</u> reported alarming statistics of the increase in Diabetes in North Carolina from 4.6% to 8.2% in the eight years from 1995 through 2003. We must continue education of diabetes, as it is becoming a major medical problem.

Extension Chair Houston Henderson reported that he held two extension workshops; one at Camp Dogwood and one in Greenville, with a total of 35 Lions attending. Several districts are actively working on new clubs. He urged the Governors not to forget the President's goal of at least one new club per district. (See attachment "I")

<u>History Committee Chair Dr. Ted James</u> reported on the work to date on the new History book, covering the dates from 1988 through 2006. The committee will meet on March 24 to assemble the materials already submitted. The intent is to make a book that is readable, interesting and that will be used as a reference for years to come. (See Attachment "J")

<u>Leadership Chair Robert Moorehead</u> has scheduled the second DGE training session for February 24-26 at camp Dogwood. Cabinet Secretary/Treasurer s will be trained on Saturday Feb. 25. The first training session for VDGE's is scheduled for May 12-13, 2006.

<u>LCIF Committee Chairperson Diane Whitley</u> reported that NC Lions donated \$65,230 to LCIF, with most of the money going to Tsunami relief. Each District has credit for at least one unnamed Melvin Jones Fellowship; Governors should insure that deserving Lions are honored. (See attachment "L")

<u>Leo Clubs Chair Paul Smith</u> announced the Leo State Convention would be held at camp Dogwood on May 5-7, 2006. All Leos are requested to pay at least half of the cost. (See attachment "M")

Mission 30 Chair Willie Hudson stated that only 4 districts are showing an increase in membership. The state totals are down by 97 members to 9309 as of December.

(See attachment "N")

Nominating Committee Chair Allen Deaton reported that all District Governors elects have been voted upon at their respective Conventions. All districts have elected Vice District Governors for the year 2006-07. (See attachment "O")

<u>Orientation Chair Edward Shivers</u> suspected that many new Lions had not had proper or any Orientation. Orientation should start with the sponsor and continue with inducting Officer as well as more formal orientation training soon after. Orientation is also valuable as a refresher to older Lions to inform them of new changes and happenings.

<u>Promotions Chairperson Pat Roland</u> stated that she had clothing sales of \$5900 at the district Conventions and the Council Meetings. Roland will make a more detailed report at the Promotions meeting following the Council meeting.

Research and Long Range Planning Chair John O'Malley presented several recommendations of the committee regarding State Committee Chair reports, PDGs acting as mentors to VDGs, attendance by VDGs to as many state functions as possible, close DG and VDG communication, insuring that chair appointees understand the jobs they are asked to do.

Retention Chair Frank Brooks urged all Lions, Zone and Region Chairs and club members to constantly be aware of members needs. Do everything necessary to retain the members we have. "It can be done" if we all work together. (See attachment "R")

Youth Exchange Chair Karen Littlefield reported 12 youth have applied for the 2006 camping season. Three host families have been confirmed. Three NC students are looking to foreign exchange. Littlefield suggested forming a website for the Youth Exchange Camp. She is also working with Logsdon to select a senior from Boys and Girls home for a foreign exchange. (See attachment "S")

<u>Vaughan moved to advance \$2000 to the Youth Exchange Chair for the 2006 Camp; seconded by Supinger. Motion Passed.</u>

<u>Public Information Chair Mike Schwartz</u> presented the proposal for a pressroom at the State Convention. The Council voted to fund the Pressroom at the November Council Meeting. They will produce daily newsletters during the Convention and a four page layout in the Lionism state newspaper. (See attachment "T")

Wilson moved to approve all State Committee Reports; seconded by Allman, Motion passed.

The Governors reported statewide sales of 334 luxury car raffle tickets to date.

Logsdon appointed an Ad Hoc committee to oversee statewide advertising, consisting of DG Gary Green, DG Paul Bledsoe, Mike Schwartz and Gwen White.

Logsdon asked for nominations for the MERL Chairs for the next three years.

Membership – PDG Gene Everette Extension – PDG Houston Henderson Leadership – PDG Bob Shook Retention – PDG I. Frank Brooks Greene moved to accept the nominations for the MERL Team: seconded by Supinger. Motion Passed.

Logsdon raised the question of using Melvin Jones Fellowship Ribbons at the state Convention.

Sandy moved to use the MJF ribbons depending upon the cost; seconded by Wilson. Motion passed

Scruggs suggested a donation of \$500 as an honorarium for First Vice President Jimmy Ross.

Wilson moved to make a \$500 donation in honor of 1st VP Jimmy Ross; seconded by Dupree. Motion passed.

Sandy moved to adjourn: seconded by Mayes. Motion passed.

The meeting adjourned at 11:55 AM.

Report to the Council of Governors Greenville, NC February 11,2006

As your Sector Coordinator for Sector I-3-A, this report is presented to update our progress at this time for Campaign Sightfirst II in North Carolina.

- 1. Appointment of District Coordinators (DC) and Group Coordinators (GC):
- All District Coordinators were appointed by the District Governors by our October 31, 2005 deadline.
- All districts were divided into Groups, essentially along existing zone lines. Some Governors chose to combine groups; which is fine.
- As of today, all Governors have appointed Group Coordinators for their districts except for 31 B and 31J. The original deadline was December 14 which was extended to January 14 and finally to January 31.
- 2. Training of District and Group Coordinators:
- This will take place March 11, 18, and 26 at three sites yet to be named. The tentative sites are Camp Dogwood, Archdale, and Greenville. It is possible that a fourth make-up date will be needed depending upon attendance.
- The training will last about 4 hours. The training will teach the GC's how to present CSF II to the clubs in their group. These club visits must be accomplished no later than **May 31,2006**. Keep that date in mind! A personal call must be made to Dr. Lee on **June 14,2006** reporting the results of our club visits. There will be no extensions of this date.
- District Coordinators will be trained to oversee this report from the GC's and in turn report it to me. Dr. Lee will be using our numbers in his report in Boston at the Convention.
- 3. What are the clubs being asked to do?
- Each club will be asked to raise funds in four ways-personal pledges, solicitation of outside gifts, a special fund raiser, and funds from the treasury.
- The emphasis will be on personal pledges over a three year period.
- The total of all four of these methods of fund raising will be used to determine the goal for the club over a three year period. Suggested goal \$125/member.
- Some clubs will do their fund raising starting in 2006-2007 and some may

choose to start in 2007-2008. Regardless they have three years to complete their goals.

- Remember the 40-40-20 rule.
- All funds raised can be used to name Melvin Jones Fellows.
- All club goals must be finalized and reported by August 29,2006.
- Banner patches and other recognitions will be available.
- 4. Model Clubs:
- North Carolina has one Model Club, the Unionville Club from 3 IE.
- I have met with them and trained them, A Model Club has been requested to raise at least \$400 per member using the four ways I described above. They assured me that they would be successful.
- As a Model club, they will begin their campaign this year and complete their goals by 2008.
- 5. Marketing of CSF II:
- At all of the District Conventions I have attended, each ID has spoken about CSF II. Within the next three months, I hope every club will have heard about it through club programs. Start putting this in your newsletter.
- I am also requesting time be allotted for a seminar at the State Convention in April. Rachel Beard, a marketing representative from International will be in attendance.
- I am requesting a table to be provided at the State Convention in April for a static CSF II display.
- I am requesting a one-hour training time slot at both the DGE training in February as well as the VDG training in May.

Needless to say, this plan was successful 15 years ago. Also, please note that the deadlines I give you are not mine—they are set by the campaign. Missing a deadline causes a logiam that makes the next step harder to meet.

This is an exciting time in Lionism. This Council has said they want to tell the story of Lionism. CSF II can be a way for you to tell what Lions do. I need your help in making North Carolina a leader in this humanitarian effort!

A fire in the cloths dryer in the Lions Cottage, smoke, smoke and more smoke, luckily that was the only damage. This made it necessary to relocate the boys to another cottage while the clean-up takes place, they should return about February 15th.

The Lions Cottage was built in 1960 and after 45 years of hard use it is time to look at some updates and renovations. The fire made it necessary to adjust the project list (painting had to be none now) before the boys return to the cottage. The remodeling projects include: new roofing, kitchen dishwasher, commercial refrigerator, renovating bathrooms, replacing blinds, install carpet, replace windows and replace some wall paneling; the total projected cost to complete all these projects is about \$47,545. Having been charged by the Council of Governors, meeting in general session, to revisit the Council Chair Selection Process the Committee met to draft language amending (A) Constitution Article V, <u>State Council</u>, Section 1, and By-Laws Article 1, Section 7, relating to the <u>State Council Chairperson Selection Process</u>, and (B) By-Laws, Article III, Section 9 modifying the job description of the Nominating Committee. At the request of the North Carolina Lions Foundation, Article VI, <u>Membership</u>, Section 3, relating to how contributions are handled was also reviewed.

Subsequent to our meeting. Committee members met, via e-mail, to review a draft of the changes and the language for the changes was finalized. On February 7, 2006, the Council of Governors & all Vice District Governors were e-mailed a copy of the changes for their review.

We look forward to the State Council meeting on February 11, 2006, at which time we will seek their advice and consent to publish the amendments so they may be placed on the agenda of the North Carolina Lions Convention to be held at the Greenville (NC) Hilton Hotel from April 20th through April 23rd, 2006.

Constitution & By-Laws Committee Report to the State Council of Governors

Ref: Amendments to the Constitution & By-Laws

At its General Meeting on November 12, 2005, the Council of Governors charged the Constitution & By-Laws Committee to revisit the Council Chair Selection Process. Also, on November 13th, North Carolina Lions Foundation requested a modification of their By-Laws regarding Membership.

Selection of a Council Chairperson

The Committee, mindful of the discussion and the charge given to it during the General Session, **recommends the following changes:**

The current language of Article V, State Council, Section 1 of the Multiple District Constitution reads:

"The Council Chairperson position shall be filled by an active Past District Governor with preference given to Immediate Past District Governors who have not served as a Council Chairperson. Consideration may also be given to any active Past District Governor who has served during the past five (5) years and has not served as Council Chairperson."

The Committee recommends that the last sentence of the above paragraph be rewritten to read as follows:

"Consideration may also be given to any active Past District Governor who has not served as Council Chairperson."

The Committee recommends that By-Laws Article 1, Section 7, relating to the <u>State</u> <u>Council Chairperson Selection Process</u> be rewritten to read as follows:

Section 7. Past District Governors interested in the position of Council Chairperson shall submit their name and resume of service by December 31^{st} to the State Council Secretary/Treasurer. After certifying qualifications, the names and copies of resumes are to be submitted to the currently serving Vice-District Governors no later than January 20^{th} .

The currently serving Vice-District Governors will interview each candidate and make their selection by the majority of a secret ballot. One Vice-District Governor shall act as spokesperson for the group during these interviews.

The selection of the Council Chairperson shall be made and announced at the February

State Council Meeting.

The Council Chairperson so selected will be a voting member of the Council of Governors and while serving shall not concurrently serve as a chairperson of any other statewide committee.

The Committee further recommends that By-Laws Article III, Section 9, relating to the description of the duties of the Nominating Committee be amended by adding additional sentences to its job description as follows:

"Also, members of this Committee will assist their District Governors in seeking qualified active Past District Governors as candidates for the position of State Council Chairperson. Such candidate's names and resumes of service shall be submitted to the State Council Secretary/Treasurer by December 31st."

North Carolina Lions Foundation By-Laws

The Committee recommends that the current language in Article VI, MEMBERSHIP, Section 3 be eliminated and replaced by the following single sentence:

Section 3: "All membership contributions will be placed in the general operating fund of the Foundation."

DIABETES AWARENESS COMMITTEE

Fellow Lions,

The chairpersons of the district Diabetes awareness committees have been working to make the clubs and communities in N C aware of the ever increasing problem of diabetes. We have presented 17 club programs and 5 non-club programs. The districts have Partnered with JDRF, Walking for the Cure, Diabetes Fair, and Vision Van for the Diabetics. Several program and other activities are planned with the club for the future. These figures would have been higher, but several district failed to respond to the questionnaire I sent out in early January.

Now let us talk a little about Diabetes Awareness. I am going to present a few figures to show you the task that is ahead for the Lions of NC. Between 1995 and 2003, the diagnosed diabetic cases in NC increased 76%, that is from 4.6% of the state population to 8.2%. That 8.2 % equates 697,000 residents of our state. We have 212,000 individuals (who are our neighbors) that do not know that they have diabetes and 527,000 who have pre-diabetes.

Pre-diabetes is an early indicator of future diabetes. The first year 11% of the pre-diabetic will develop Type 2 diabetes. At the end often years most will have diabetes unless their lifestyle changes. Some of the factors to consider are (1) weight adjustment, a lost of 5 to 8 % will make a big difference; (2) Exercise, 30 minutes per day 5 days per week; and (3) diet, a least 5 fruits and vegetables per day. It is estimated that by 2030, the number of diabetics will double.. In the U S, we now have 41 million between 40 and 74 with pre-diabetes.

We, as Helen Keller's Knights of the Blind, need to make N C public aware of the ever increasing growth of diabetes in N C. Not only because of the health factors: cardiac diseases, high blood pressure, circulation problems, renal problems, vision and others, but quality of life. Let's look at vision, 26 % of the Type 2 diabetics will develop some type of vision disease. Most will have some level of diabetic retinopathy. It is much better to help prevent blindness than to provide a cane or seeing eye dog for them.

So I am asking the incoming District Governors to consider a chairperson who is dedicated to the prevention of blindness by making the fellow North Carolinians of your district aware of the prevalence of diabetes and the ways to help prevent it.

RESEARCH AND LONG RANGE PLANNING COMMITTEE REPORT TO

N.C. LIONS COUNCIL OF GOVERNORS February 11,2006 DISTRICT GOVERNORS, VICE

DISTRICT GOVERNORS, FELLOW LIONS

Our committee, which is comprised of the following members:

A-Larry F Gasperson, PDG B-Allen W. Deaton, PDG C-John J O'Malley, PDG D-Ralph Holmes, PDG E-Dr. Ted L. James, PDG F-Charles D. Smith, PDG G-James Valsame, PDG H-Barbara Mayes, DG J-John T. Miller, 111, PDG

Is working on a 2 to 5 year Long Range Plan as ordered by this Council. We have asked each State Chair under the Council to submit their recommendations for their area of responsibility by February 2006. To date one State Chair has responded, PDG Ed Shivers. To be fair there are a number of committees where it would be extremely difficult to plan beyond the current year because of the repetitive nature of their duties.

Our committee has a few recommendations to make as follows:

- That State Chairs when making recommendations to the Council, be required to have the concurrence of a majority of the District Chairs. Sometimes the State Chair makes recommendations without majority approval.
- 2) That VDGE be required to choose one or more (willing) PDG's to act in an advisory capacity. In effect mentoring the individual Lion candidate thru the VDG and DG process.
- 3) We also recommend that the VDGE should attend as many of the following as possible: District Convention, State Convention, Budget Hearings, VIP Fishing Tournament, Council and Foundation Meetings.
- 4) We further recommend that the District Governor be required to keep the VDG up-to-date on what is taking place in the district.
- 5) When naming district chairs the District Governor must ask the individual Lion if they know what is required of them, if they do not, then see that such information is supplied to them.
- 6) A problem that needs to be addressed is the high monetary goals set for the clubs when membership is declining and more money for service projects is required in their communities.

These are our recommendations and suggestions. We are still working on some other items including Orientation and training at the Club level among others. One other area for discussion is how to get committees together to work on these problems when the District Chairs do not receive any reimbursement and work and other schedules make it difficult to meet. We know other committees are working on some of these problems and would appreciate knowing who is working on what.

Greetings from Florida!

As of Friday February 10th, All 12 spaces in our camp have been reserved. Applications have been received and accepted for 6 students, with the remaining 6 to be accepted and received before March 1st. The accepted applicants represent Austria, Romania, Belgium, Germany, Denmark and Slovenia: four females and two male students age 17-20. I am waiting on confirmations from Hong Kong, Nigeria, Italy, The Netherlands, Turkey and Hungary.

ALL 12 spaces will be filled, as I have more students applied should any of the above six countries choose not to participate.

I have confirmed 3 Host Families: ALL from the western part of the state as the students will arrive at the Charlotte International Airport on July 1, 2006. I am in need of 3-5 more host families.

I am actively working to arrange an exchange for 3 students from North Carolina. Two students are from the St. Andrews Campus Club. There are no confirmations to date. I expect confirmation within the month.

I would like to present for discussion two issues:

- 1. I would like to create a website for the North Carolina Camp. I think it is vital to visually communicate with the potential campers as well as the Lions throughout our state. It would be a tribute to the Lions Clubs that take the initiative to welcome these students to their towns and into their homes.
- 2. I would like to explore the possibility of arranging an exchange for a junior or senior student from the Waccamaw Boys and Girls Home. We could award them the scholarship available and provide the funds for travel. If there is interest, I believe it could be arranged for this summer. This could be a life changing experience at a nominal expense. With council approval, I will work with Brad Logsdon and the staff at the Boys and Girls Home to choose the student and make the exchange.

I am also requesting space at the State Convention. I will have information available for potential students and host families as well as photos from past camps.

The Public Information & Education Committee would like to thank the State Council and the State Convention Committee for allowing our committee to participate in the 2006 North Carolina Lions State Convention by hosting the Media Room.

Enclosed you will find our projected expenditures for the convention. In exchange for inviting us to participate, the committee will provide the following services:

- Produce a media release to be distributed to Greenville-area media outlets prior to the convention.
- Coordinate any media coverage as needed.
- Produce a color pre-convention newsletter that will be made available to attendees.
- Produce a daily newsletter that will provide a review of convention events and a preview of activities. The newsletter will be made available to attendees.
 - Provide a photographer for all convention events
 - Create a photo display board of convention activities
 - Provide each district governor and vice district governor with a photo CD of the convention
 - Provide each member of the state convention committee with a photo CD of the convention
 - Provide the international guest with a photo CD of the convention
 - · Provide each district governor and vice district governor with a photograph with the international guest.
 - Provide a photographer to travel with the international guest
 - Provide four pages of convention coverage in the newspaper of the North Carolina Lions Foundation.
- Create and distribute a press release/with photo of recipients of an international award to the respective newspaper of record in their hometown.

In 2004 and 2005, the State Council provided a complimentary room at the convention site in exchange for staffing the Media Room. The projected expenditure for the 2006 state convention includes this expense, along with the total cost of equipment and tickets to attend the International Family Dinner, Friday Fun Night, Tail Twister Breakfast, Past District Governors' Luncheon and District Governors' Banquet. As for supplies, most items will be donated. Expenses for additional supplies purchased on site will be submitted for reimbursement.

In order to save printing costs, the Public Information & Education Committee is recommending the rental of a copier. I have contacted an office equipment rental business in Greenville that has agreed to rent the North Carolina Lions for a total of \$450.
