Council Chairman James Shuart called the fourth 2004-05 Council meeting to order at 8:05 AM. The meeting was moved up to 8:00 AM, to allow the Governors and Lions to attend the funeral of Past International President William L. Woolard in Charlotte, NC, in the afternoon. A tour bus was reserved to provide transportation to and from the funeral.

District Governor F. James Boehm gave the Invocation and District Governor Pat Roland led the Pledge of Allegiance.

For the record, the Council met in caucus on Friday evening, April 29, 2005, all District Governors were present. All District Governors, all District Governors Elect, and Past International Directors Lacy Presnell and Sid Scruggs were present for the Saturday Council Meeting.

District Governor Hunter Garbee was appointed as parliamentarian.

Immediate Past International Director Sid Scruggs commented on changes in officers at Lions Clubs International. Donna Rebeck has retired as Treasurer, Peter Lynch will be managing the Extension and Membership Division, and Phillip Albono will manage the Lions Clubs International Foundation Division. A new item being brought to the International Convention is an increase in Lifetime Membership fees from \$300 to \$500. It was also decided that Membership keys will no longer be given for members brought in though club extension, due to abuse of the system.

Scruggs has been appointed as co-chair of 1st Vice President Ashok Mehta's worldwide "<u>Mission 30 Team"</u>. His responsibilities will be North And South America as well as Europe. He also reported that Foundation President Harvey Whitley has been named the North Carolina representative for "<u>Sight</u> First phase II"

<u>DG Gene Everette moved to accept the Minutes of the November Meeting: seconded by DG Alan King. Motion passed.</u>

State Secretary-Treasurer George Ohm presented the <u>Financial Statement</u> as of April 28, 2005. All dues are accounted for, Youth exchange has approx. \$3166 available for this year's camping. Donations to the Governors' Capsule program have reached \$8450. Liberty day funds total \$1344.25. The current Leadership Committee balance is \$352, which may be exceeded when the Vice District Governors meet for training on May 13-14. The current Checking Account Balance is \$37,994.18.

Ohm pointed out that his expenses will exceed his budget and asked for an increase of \$300 to line item 290. Everette moved to increase line item 290 by \$300, seconded by King. Motion passed.

Ohm went on to advise of his financial account for the South Eastern Leadership Institute. An initial grant was received from LCI along with tuition fees from 37 students. The expenses were just received from the director Dr. Beverly Roberts, and they will be paid.

<u>District Governor Keith Peedin moved to accept the February Financial Report, seconded by Everette.</u>

Shuart called on <u>PDG Joe Silvers</u>, Chairman of the NCLF Jack Stickley Committee. Shuart took this opportunity to present Silvers with a <u>Progressive Jack Stickley Fellowship</u> from the Council for his dedication and untiring efforts to further the Jack Stickley Fellowship across the state.

Shuart called upon Foundation President Harvey Whitley for the <u>Foundation Report</u>. Whitley added his congratulations to Silvers for all that he has done to promote the Jack Stickley Fellowship. He thanked Scruggs for appointing him as the North Carolina Representative for "Sight First II".

He stated that we were approximately 80 names short of the 300 applications needed for the <u>State Lions License Plate</u>. He will extend the sign-up through May 30, 2005. This is the 3rd time we've tried to get a Lions licenses plate and he's asking the Governors to help us meet the goal.

Whitley continued with his report of the Foundation, stating the <u>Wanda E. Lineberger Dormitory</u> and the <u>VIP Sensory Garden</u> were complete and ready for the campers coming within a month. Dedication will be on May 1, 2005 at 3:30 PM. New policies of random drug testing and background checks are in effect. He noted that the counselors appear to be older than previous years. A <u>Speakers Bureau</u> has been established for use by clubs and districts to assist in sharing what the Foundation was doing.

Executive Director Steve Walker noted that the <u>Certification of Delegates</u> would be held from 9:00 AM thru 12:00 noon on Sunday for the NCLF General Meeting. He in turn thanked the District Governors and all Lions in the state for their efforts to further Lionism.

Shuart reported on his and Kally's attendance at the <u>Lions Day at the United Nations</u> in New York. The <u>Peace Poster winner</u> was announced as a youth from Hong Kong and was presented with a \$2500 prize to use for education. There was 23 runner-ups receiving \$500 each. This year there were 350,000 entries world wide into the Peace Poster Contest. The 2005-06 theme will be "Peace Without Borders"

Shuart commented that the <u>Courier Program with the Eye Bank</u> that is apparently working in other states is dead in North Carolina due to lack of interest.

The concept of a <u>single Multiple District Directory</u> for the entire state is also a dead issue due to the differences between the districts as well as the difficulty to secure district information in a timely manner.

Shuart called upon Mike Schwartz to present the proposed Budget for the <u>Pressroom for the State Convention</u>. Schwartz indicated that the only expenses not funded are for pressroom supplies of \$482.00. Schwartz also distributed a form to be filled out by Lions statewide as a tribute to the passing of Past International President Bill Woolard. Excerpts will be included in the next Lionism Newspaper. (See attachment "D")

DG Jim Boehm made a motion to fund the Pressroom Supplies with a donation of \$50 from each District amounting to \$450.00. Everette seconded the motion. Motion passed.

Shuart called upon PDG Herb Justice to present the <u>State Convention Report</u>. Justice reported that plans are nearly complete but stated that Convention advertisements are still needed to help offset the costs of the convention. The Governors went over the Schedule of events, suggesting changes where appropriate. The Resolutions Committee Chairmanship was in question, so PCC David Butler volunteered to serve as Chairman for the 2005 State Convention. (See attachment "E")

Boehm made a motion to approve the State Convention report as corrected and the appointment of PCC David Butler as Resolutions Committee Chair; seconded by Everette. Motion passed.

PDG David Boyd reported that the plans for the <u>2006 State Convention</u> at the Greenville Hilton are well under way. The Hilton rooms will be \$79.00 plus tax, with spillover rooms available at the City Bistro Hotel for \$69.99 plus tax. (See attachment "F")

Boehm presented the <u>Report from the NC Commission for the Blind</u> in PDG John Miller's absence. (See attachment "G"

Statewide Committee Chair Reports

Boys & Girls Home - Chair PDG Brad Logsdon reported that one of the primary services of Boys & Girls Home is Foster Care, where they are caring for 71 children ranging in age from a few days to 20 years of age. Daryl and Stacy Parks have been appointed as the new house parents for the Lions Cottage, which is currently housing middle school aged children. A new program of Independent Living aimed at the older boys was begun in October 2004, teaching personal finance such as buying a car, insurance, etc. A similar program will be offered to the older Girls in May, 2005. The number of graduates going on to college shows the influence of Boys & Girls Homes in preparing young people for success in life.

Constitution By-Laws – Chair PDG Ron Kelley out lined the changes and amendments to the State Constitution and By-Laws published in the spring edition of the "Lionism" newspaper.

Extensions - Chair PDG Houston Henderson urged the Governors and Lions not to stop working on Extensions. He suggested surveying your local areas for potential sources of members and locations for service.

Historian - Chair PDG Herb Justice announced that they installed the frames for each District's Cabinet on the District Bulletin Boards. Most of the District Governors sent in photographs, some have not. Along with inventorying items for the new history book, the committee has sent an Inquiry form to every Club President for a short history of each club. (See attachment "K")

Leadership - Chair PDG Bob Moorehead announced the date of May 13-14 for the VDG training session at Camp Dogwood. (See attachment "L")

Liberty Day - Committee Chair John Kearney reported on the Liberty day Celebration in Raleigh on March 12th. Though only 30 Lions and guests attended, it was a great success. Kearney stated that he was seeking quotes from local printers for Liberty Day booklets for next year. (See attachment "M)

Page 3 of 5 Attachments: A thru T Leo Clubs - Chair Larry Covington indicated that the Leo's State Convention at Camp Dogwood was cancelled for this year. As he will serve as D31-D Vice District Governor, Covington will tender his resignation as Leos Committee Chair on June 30. He advised of the partnership agreement between Lions Clubs International and the Hugh O'Brien Youth Leadership organization," HOBY", to further encourage youth in Leadership. A HOBY seminar will be held in Raleigh at NC State University on June 10-12, 2005.

Lions Clubs International Foundation – Chair PCC Diane Whitley reported that as of February 2005, LCIF and Lions around the world have donated over 6 millions dollars to the tsunami relief. LCIF expects the total to reach at least 10 million dollars. At the April board meeting LCIF voted to spend \$1.25 million dollars on each the four islands destroyed by the tsunami.

Nominating Committee – Chair Whitley reported that each of the nine districts have a District Governor Elect, and with the exception of District 31F, all districts have a Vice District Governor in place.

Promotions – Chair PDG David Boyd said sales were brisk all year and the new knit shirts were selling well. He still has some of the all cotton shirts on hand, which may have to be further discounted. He asked that the Governors send in their payments to him for the State Trading Pins. (See Attachment "P")

Research and Long Range Planning – Chair PCC John O'Malley reported on a meeting held in following the Budget hearings with the Governors and Vice Governors in attendance. He commented that redistricting had been discussed and studied since 1989. Though several plans were considered over the years, none has ever been approved by a council. There was no consensus reached during the latest meeting. The Committee will be looking towards the incoming council for direction. He suggested the need for a 2-year and a 5-year plan.

Retention - Shuart received a letter of resignation from PDG Jim Caudle as Retention Committee Chairman due to health reasons. Understanding that the incoming DGE's had asked PDG I. Frank Brooks to Chair The Retention Committee for 2005-06, Shuart appointed PDG I. Frank Brooks to fill the vacancy.

Women's Membership Development - Chair PDG Martha Butler commented on the passing of Past International President Bill Woolard, and that he gave each of the Governors in her Council the book entitled "Keep On Keeping On", and challenged each Governor to "Keep-on keeping on" for Lionism. He firmly believed in encouraging women to serve in partnership with men. Her report unfortunately, showed a loss of both male and female members this year. (See attachment "R")

Youth Exchange - Shuart expressed the Governors' concerns that Youth Exchange Chairperson, Lion Paulette Gasperson had been using a considerable amount of her own money to fund each camping season until she submitted an expense voucher. The Governors voted to advance \$2500 from the Youth Exchange Program Funds to Gasperson for this year's program. She was asked to submit an expense report at the end of the camping period.

Gasperson reported that three North Carolina students were going overseas in the Youth Exchange Program, one to Japan, one to Austria and the third to Italy. She asked that all Lions pass on the word so other North Carolina students can take advantage of the program in coming years. She outlined the planed activities for this year.

Youth Outreach - Chair Past Council Chair Jim Irvin stated that he had contacted all members of his committee and found no new activities. He has distributed a folder to the incoming DGEs describing

Page 4 of 5 Attachments: A thru T the youth activities across the state. He recommended that a new committee be formed "Lions Opportunities for Youth" which would be comprised of all of the Chairs regarding youth to coordinate, discuss and review youth activities. (See attachment "T")

Boehm moved to approve the State Committee Reports: seconded by King. Motion passed.

The meeting was suspended at 10:30 AM to allow travel to Charlotte to attend PID Woolard's funeral.

The meeting resumed at 4:00 PM.

District Governor's Capsule Program - The Capsule Program collected \$8450 to date. After paying out the prize money, \$5850 will be distributed to Camp Dogwood, South Eastern Guide Dogs and Juvenile Diabetes Research.

Prizes were drawn:

1st prize of \$1200 - Linwood Lions Club, D31-E

2nd prize of \$900 - Raleigh South Eastern Lions Club, D31-G

3rd prize of \$500 - Pilot (Firehouse) Lions Club, D31-G

Shuart stated that \$1750 was required to name a dog at South Eastern Guide Dogs and the original 25% share only came to \$1463. <u>Garbee moved to change the distribution to allow \$1750 to be sent to SEGD; seconded by King. By raised hand vote, the measure was defeated by 5 to 4.</u>

The Governors had originally intended to send the third check to The Juvenile Diabetes Research Association, however since the NCLF cannot dispense funds out of the state, it was decided not to send this money should also stay within the state. By mutual consensus the Governors agreed to send the check to The UNC Diabetes Eye Care Clinic to be marked for Juvenile patients.

Distribution of the proceeds of \$5850:

NCLF – Furnishings for new Dormitory = 50% or \$2925.00 South Eastern Guide Dogs = 25% or \$1463.00

UNC - Diabetes Eye Clinic = 25% or \$1463.00

In securing passengers for the Bus to transport the Governors to Charlotte, the Governors had collected an excess of \$70.00 over the cost of the bus. <u>Garbee made a motion to donate the excess \$70.00 to the William L. Woolard endowment in honor Woolard; seconded by Boehm. Motion Passed.</u>

The Council will next meet at the State Convention in Raleigh, May 26-28, 2005.

Shuart reminded the District Governors and District Governors Elect that they are to be in dress uniform for the International Night Dinner on Thursday. All Governors are to bring their District Governor's Banners on Thursday afternoon, May 26.

The 100 participants will be allocated as follows: Japan (33), Korea (20), Multiple District 300 Taiwan (15), Thailand (6), Singapore/Malaysia (4), the Philippines (8), Hong Kong (1), China (3), other (10). Additional participants will be accommodated on a space available basis, and will be responsible for all

- expenses associated with their participation in the institute with the exception of materials costs.
- 3. A seminar targeted at potential Lions leaders from District 380 will be presented during the 2005 International Convention.
- 4. A test of a Faculty Development Institute will be conducted in 2005-2006.

MEMBERSHIP DEVELOPMENT

- 1. Authorized the Membership Development Committee to draft a long-term membership development plan, to be completed by July 2006 and forwarded to the Long Range Planning Committee for review.
- 2. Approved funding to continue special membership development initiatives in MD 116 (Spain) and MD 307 (Indonesia) in the amounts of US\$25,000 and US\$15,000, respectively, for the year 2005-2006.
- 3. Approved the Family-Friendly Lions Club initiative and its guideline materials for distribution and implementation, with the objective being to promote family involvement in Lions club activities among interested clubs.
- 4. Approved the charter application for the Guzelyurt Yesilada Lions Club in the undistricted area of Cyprus, with the charter issued upon the appointment of a Coordinating Lion for this undistricted area.
- 5. Approved an increase in the Life Member fee to US\$500, subject to the proposed constitutional amendment on this increase being approved at the 2005 International Convention.
- Adopted guidelines for the China Affairs Coordination Committee for inclusion in the Board Policy Manual.
- 7. Amended a resolution approved at the October 2004 board of directors meeting clarifying an effective date of June 30, 2005 for revisions to Membership Key Award Program.
- 8. Amended a resolution approved at the October 2004 board of directors meeting to clarify that the proposed increase in the Life Member fee shall be US\$500.

PUBLIC RELATIONS

- 1. Increased Ambassador of Goodwill Award from 35 to 40 for Lions year 2004-2005.
- 2. Added Campaign SightFirst II National/Multi-national Coordinators, Sector Coordinators, District Coordinators and Group Coordinators into the Order of Precedence.

Report: April 30, 2005

The Boys & Girls Homes of North Carolina continues its mission of serving children through our residential group care facility in Lake Waccamaw and our foster care and adoption program. Our foster care and adoption program is now in nine counties with 61 licensed homes and 71 children being served currently. Our foster care children range in age from a few days old to 20 years of age. We now have foster care and adoption offices in Lake Waccamaw and Kenansville. We also have had two adoptions this year and up to 20 more foster care children may be adopted by the end of the calendar year.

At the Lion's cottage in Lake Waccamaw, Daryl & Stacey Parks are the new teaching parents in the cottage. The Lion's cottage is also now focusing on taking care of our younger boys at the middle school level. Two of the stars of the Lions Horse Show in December, Chad & Charles will be attending horse camp this summer and are looking forward to the experience.

Boys & Girls Homes started a program for Independent Living for our older boys back in October. The program provides speakers for the young men on such topics as personal finance, buying your first car, insurance, resumes, etc. to help prepare them for the real world. Several of the Independent Living Program residents have also been involved in the greenhouse program and have taken a very active role in managing and organizing the operation of the greenhouse. The Program for Independent Living will is expanding to include our girls beginning in May.

Several of our Independent Living residents have been accepted into colleges and universities. Lawrence has been accepted at UNCW and NC State. Sean has been accepted to NCA&T. Elton has been accepted to Grambling State University and San Francisco Academy of Art. Meanwhile two additional soon to be high school graduates are looking toward their futures. Tyrone will be going into the Job Corps and Denise is looking at Pembroke State to further her education.

With the State of North Carolina changing some programs and reducing their funding, Boys & Girls Homes is suffering a SEVERE FINANCIAL CRUNCH. If your Lions club has money budgeted for Boys & Girls Homes, PLEASE forward these funds as soon as possible and designate them toward the "General Fund". Thanks for your continues support of the children at Boys & Girls Homes.

Thank you for allowing me to serve those less fortunate than ourselves.

"There is absolutely no way I could have arrived at my current position in life without my education." Robert Hardy, Alumnus, Boys and Girls Homes.

Former resident Robert Hardy is up front about the role of education in his life. At 38, he is currently employed by American Eagle Airlines as a Captain and Test Pilot on an EMJ145 Aircraft and readily acknowledges that receiving an education played a major role in where he is today.

Robert and his wife Lori have been married 14 years and they have a son Ethan, three years of age. They live in a suburb of Dallas, Texas, and it is quite obvious that Robert is proud of his family and his work.

Of his life a Boys and Girls Homes, Robert says, "I arrived at Lake Waccamaw in October 1980. I lived in the Lions Cottage until graduating to the 'gymnasium' apartment (a room in the Boys and Girls Homes gymnasium established as a transitional living area for residents after high school graduation), and stayed there until going to lowa to attend college in the fall of 1984. Being at Lake Waccamaw provided me with the structure I needed during my adolescent years. Trying to get along with so many other boys who also came with needs like me was a growing experience. If I could compare it to something, I think for me that it was a lot like college with supervision. I was given the freedom to grow, but received a lot of guidance along the way."

"I have many fond memories of Boys and Girls Homes. Many days I spent playing ping-pong. I won't say how many times I won (still in dispute)! I have lots of pleasant memories: working for Leon Dudley (campus maintenance) on the tractors, watching my friend Chris play with snakes found in the woods, and working for Mrs. Thelma Green in food service. Being in the choir was great fun. I couldn't sing, but Mr. Tutor (Jimmie) was very forgiving! When I was 16 years old, I was allowed to drive the yellow school bus back and forth from campus and, boy was that a thrill. I still can't believe they let me do

that. There were just so many good memories it's impossible to name them all! I will say that I am very thankful for the caring staff at Boys and Girls Homes, and especially Mr. Bill Morrison, a soft spoken man who played a large part in my life and has my admiration and respect."

"Boys and Girls Homes encouraged me to continue my educational pursuits. After high school, I attended and graduated from the University of Dubuque in Dubuque, Iowa, with a Bachelor of Science Degree.

My majors included Flight Operation, Business Administration and a minor in Aviation Management. I obtained a lot of my flight training there along with my private pilot license, commercial pilot license and certified flight instructor's license."

"How has education played a role in my success? Well, there is absolutely no way I could have arrived at my current position in life without my education. The subjects I studied in college had a direct affect on the progress of my career. I chose a field of study that required me to know things before being employed in the working world. Education gave me the tools needed to teach people how to fly airplanes and how to complete projects. I showed me how to set goals and complete those goals within deadlines. My current position as a test pilot requires me to research problems with airplanes and to make an educated decision on whether the aircraft is safe to fly. But, I guess my best education comes from dealing with great people everyday. Many like the great people at Boys and Girls Homes. The have always been there supporting and cheering me on. Some had doubts, including myself at times. But, most encouraged me and that fueled my desire to fly airplanes. I offer a sincere 'thank you' to the entire staff at Boys and Girls Homes."

Robert's position is a testament to the encouragement he received to strive for his dreams and make the most of his educational opportunities. Boys and Girls Homes is proud that Robert is one of ours.

Multiple District 31 Constitution & By-Laws Committee Park Inn, Hickory, North Carolina

Committee Report

Having been charged to amend portions of our Constitution and By-Laws by the Council of Governors, meeting in General Session, in Rocky Mount, N.C. on November 13, 2004, and being charged to amend the By-Laws by the North Carolina Lions Foundation at their meeting on November 14, 2004, also in Rocky Mount, N.C. the Constitution and By-Laws Committee drafted language to amend the following:

- A) Multiple District-31, Constitution, Article V, Section 1, <u>State Council</u> and By-Laws, Article 1, <u>District Nominations and Elections</u>, etc., to reflect the new requirements for selecting the Council Chairperson.
- B) Multiple District-31, Constitution, Article VII, State Convention and State Council Fund to reflect a proposed increase in the annual per capita tax, effective July 1, 2005.
- C) Multiple District-31, Constitution, Article VIII, Committee and Fund for the Promotion of North Carolina at the International Convention to address the funding needs in promoting a North Carolina International Executive Officer seeking possible selection as International Second Vice President.
- D) Multiple District-31, Constitution, Article V, Section 2, to add back two sentences inadvertently left off when the Committee made their revisions in 2001, dealing with the election and tenure of the Council Secretary-Treasurer.
- E) North Carolina Lions Foundation, By-Laws, Article IV, Officers and Directors, Section 10, to reflect the current practice of selecting a first year and second year director for the Executive Committee.

The language for these amendments were approved by the Council of Governors at their February 12, 2005, meeting in Raleigh, N.C. and published in the Spring Edition of NCLF Newspaper **Lionism** in accordance with Article XVI, Section 2 and Article VI, Section 2, Respectively, of the Multiple District-31 Constitution and By-Laws.

Selection of a Council Chairperson:

The Committee, mindful of the discussions during the General Session, as well as the report made by the Ad-Hoc Committee appointed to study this matter, recommends the following changes:

1) The current language of <u>Article V, State Council, Section 1,</u> reads:

"After their installation at the International Convention, the State Council, composed of all District Governors, shall elect its Chairman prior to the adjournment of that International Convention."

This language should be deleted and replaced by the following:

Article V

State Council

Section 1. The Council Chairperson position shall be filled by an active Past District Governor with preference given to Immediate Past District Governors who have not served as a Council Chairperson. Consideration may also be given to any active Past District Governor who has served during the past five (5) years and has not served as Council Chairperson.

This Council Chairperson position shall be filled in accordance with Article I, Section 7 of the By-Laws.

By-Laws

Article I

District Nominations and Elections, State Council Chairperson Selection Process, and Endorsement for International Office

It is recommended that the Title to this Section be amended as highlighted above and that the current Section 7 become Section 8 and that the new Section 7 read as follows:

Section 7. Past District Governors interested in the position of Council Chairperson shall submit their name and resume of service by September

30th to the State Council Secretary/Treasurer. After certifying qualifications, the names and copies of resumes are to be submitted to the currently serving Vice-District Governors no later than October 15th.

The currently serving Vice-District Governors will interview each candidate and make their selection by the majority of a secret ballot .One Vice-District Governor shall act as spokesperson for the group during these interviews.

The selection of the Council Chairperson shall be made at the November State Council Meeting.

The Council Chairperson so selected will be a non-voting member of the Council of Governors.

Proposed increase in the Annual Per Capita State Convention and State Council Administrative Tax, effective July 1, 2005

Article VII, State Convention and State Council Fund

In order to alleviate the ongoing shortfall in Multiple District annual revenues, the Council of Governors has proposed to put before the General Membership, for their approval, an increase in the annual per capita tax of \$1.00, effective July 1, 2005. This increase would bring the annual per capita tax to \$3.50 from \$2.50. Accordingly, the Constitution and By-Laws Committee recommends that the first sentence of Section 2 of Article VII, State Convention and State Council Fund be amended to read as follows: (the remaining portions of this Section 2 remain as currently stated)

Section 2. In lieu of a State Convention registration fee, an annual per capita State Convention and State Council Administrative Tax of \$3.50 shall be levied upon each member in the State and shall be paid in advance by each club, in two (2) semi-annual payments as follows: \$1.75 per member on September 10th and \$1.75 per member on March 10th of each year.

Funding the promotion of an International Executive Officer

The Committee addressed the need to add a second paragraph to Article VIII, Section 1, Committee and Fund for the Promotion of North Carolina at the International Convention. As currently written, there is no language addressing funding needs in promoting a North Carolina International Executive Officer seeking possible selection as International Second Vice President. Taking its charge from the Council of Governors to correct this discrepancy, the Committee suggests the following:

A second paragraph should be added to Article VIII, Section 1 to read as follows:

Beginning July 1, 2005, an additional tax of \$2.00 shall be levied annually upon each member in each District and shall be paid in advance by each club in the District in two (2) semi-annual payments as follows: one-half (1/2) on September 10th and one-half (1/2) on March 10th, with all proceeds there from, through June 30, 2011, being placed in the Executive Officer Campaign Savings Account. If a North Carolina Lion is elected International Second Vice President in 2007, all proceeds there from during the period July 1, 2005 through June 30, 2011 shall be used, as approved by the Promotions Committee, to promote and Honor said International Executive Officer through his term as Immediate Past International President. If no North Carolina Lion is elected International Second Vice President in 2007, or ceases to be a viable candidate, this additional tax shall terminate June 30, 2007; otherwise it will terminate June 30, 2011.

Multiple District 31 Constitution

Article V, State Council

When the Committee made their revisions to the Constitution and By-Laws in 2001, two sentences were inadvertently left off Article V, Section 2, which deals with the election and tenure of the Council Secretary-Treasurer. To correct this discrepancy, the Committee recommends that Article V, Section 2 be amended to read as follows:

Secretary-Treasurer, who in the discretion of the State Council, may be other than a State Council member, to a one-year term. No Lion may serve as State Council Secretary-Treasurer for more than five (5) consecutive one-year terms. The new State Council may, at its discretion, consult with the outgoing State Council concerning the performance of that Council's Secretary-Treasurer in considering the election of the Secretary-Treasurer for the new State Council.

North Carolina Lions Foundation By-Laws

Article IV, OFFICERS AND DIRECTORS

Section 10: The first sentence of this section reads, "The Executive Committee shall be the President, Immediate Past President, First Vice-President, Second Vice-President, Secretary, Treasurer, the Chairman of the State Council of Governors of Multiple District 31 of Lions Clubs International or his appointee, one member from the second year directors, elected by his group prior to July 1, and one member from the first year directors, elected by his group at the August meeting of the Board of Directors to serve until a successor is elected."

This latter part of the first sentence (which we have italicized for emphasis) does not correctly reflect when the selection of the two directors is actually made; both are elected in August.

To correct the first sentence to reflect the current practice, the Committee recommends that Article IV, Section 10 be reworded to read as follows:

The Executive Committee shall be the President, Immediate Past President, First Vice-President, Second Vice-President, Secretary, Treasurer, the Chairperson of the State Council of Governors of Multiple District 31 of Lions Clubs International or his or her appointee, and one member from each of the first and second year directors, elected by their group at the August meeting of the Board of Directors, to serve till a successor is elected.

DISTRICT GOVERNORS, VICE DISTRICT GOVERNORS, FELLOW LIONS

Our committee met on April 9, 2005 at Camp Dogwood with most of the Governors and Vice District Governors in attendance. The subject was REDISTRICTING IN N.C. and we were looking for input from all in attendance about how best to accomplish this task. This committee has been reviewing this subject since 1989. With the latest plan submitted in 2002. None of these plans has ever been approved by the Council in office at the time. A lot of time and effort has gone into these plans, so we wanted the current Council and the incoming Council to participate, so we could get a better idea as to what they felt we needed. It was an interesting meeting but very little was accomplished. What we have to understand is that we need to put aside our prejudices and look at what is best not just for our district but for the Lions of N.C. We have a problem and we cannot solve it by ignoring it. Eight of our nine districts are below 1,250 members and the 9th one is very close. One of our biggest problems is we do not plan ahead on the State level. We should have a Five Year Plan and also a Ten Year Plan. We cannot continue to ignore our problems, we must do something about them. The Council tells the committees what their priorities are, we need the incoming Council to give us direction in this regard.

Women's Membership Development and Participation Committee Report April 30, 2005

Thank you, Governors for allowing me to serve the Lions of our state in this position for the 2004-2005 Lions Year and for the support you have given me and your District Chairpersons. As all of you know the Lions of this state lost a good friend and great Lion on Tuesday night and we all pray for his family. PIP Bill was a great supporter of women serving as Lions as well as Lioness. In February of 2000 when Past President Bill met with our incoming council he gave each of us a book entitled "Keep on Keeping On written by Dr. Richard Crowder. He challenged us to read this book and to "Keep on Keeping On" serving others through Lionism. I am asking you Governors, and fellow Lions, to join us now in that pledge, to Keep on Keeping On in our life as Lions so that when we are gone we like Lion Bill will have made a difference in the lives of others. Past President Bill also firmly believed in men and women serving together as he and his loving wife Ginny have done as Partners in Service. Let us pledge now to honor his memory by bringing more men and women into our clubs so that they and all of us can serve together as Partners in Service.

Inviting women to serve the less fortunate of our communities as lions, is not only important to us as Lions it is also important to our communities. As I have stated before women in all of our communities assisted the male members of our clubs for many years before the delegates voted in 1987 to invite women to join and serve together with the male members. Always remember that those in need of our assistance don't care if the hand held out to them in service is male or female. They only know and care that you as a Lion cared enough to help.

In May I will present to you my final report for the year and I sincerely hope that report is better than the one I have for you today. The latest figures I have for you at this time shows that on February 28, 2005 there were 1,681 female members and 7,837 male members for a total membership 9,645 members in 393 Lions Clubs in North Carolina. Of these 393 clubs all but 80 had female members at that time. On June 31, 2004 there were 1884 female members, 7,957 male members for a total membership of 9,841 members. This tells us that since June we have lost 203 female members and 220 male members. Our percentage of female members has also dropped from 19.4% to 17.4%. The cumulative report from Lions Clubs International shows that since June 31, 2004 we have gained a total of 715 members statewide, but we have dropped 911 members for a net loss of 196 members. We can and must do better. Robert Schuller once said "The good new is that the bad news can be turned into good news when we change our attitude". May we all move forward with a positive attitude and grow our membership after all it is the life blood of our organization.


