District Governor Gwen White led the Pledge of Allegiance and District Governor Bill Womack gave the Invocation.

For the record, the Council held a Workshop on Friday evening April 29, 2011. All eight District Governors were present at the Workshop and are present at today's State Council Meeting.

CC Staley welcomed all to the fourth and last State Council Meeting of the 2010-2011 Lions Year and then made a few remarks about the state of our Multiple District.

CC Staley recognized PID Lacy Presnell for a few remarks. Lacy used this opportunity to present PCC Gary Greene with a Presidential Certificate of Appreciation for all he had done for the LCI Board Meeting held in Cary, NC earlier this month.

Governor Steele moved that we approve the Agenda for today's meeting; seconded by

Governor Sprinkle. The motion passed. (See attachment A)

Governor White moved to accept the Minutes of the February 12, 2011 State Council Meeting as distributed to all District Governors and Vice District Governors and as posted on the web site of MD-31; seconded by Governor Camaioni. The motion passed.

PCC Harvey Whitley agreed to serve as Parliamentarian.

New Business:

State Council Secretary-Treasurer Ron Kelly presented the State Council Financial Report dated 04/27/11. He began by commenting that the ledger and bank accounts had been reconciled and all invoices had been paid. He noted that all dues for the year have been collected. He then reviewed pertinent income and expense items. He closed his remarks by noting that the total assets of the State Council, as of 04/27/11, were \$103,767.97: \$48,718.11, checking balance on hand, and \$55,049.86 in the money market account. (See attachment B)

<u>Governor Suggs moved to accept the State Council Financial Report; seconded by Governor White. The motion passed</u>

CC Staley asked DG's Suggs and White to present their final report on the Council of Governors State Fund Raising Auction Project. DG White opened their comments with a" thank you" to the North Carolina Lions for their support of this project. She did note that through their advertising, the public was invited to participate. DG Suggs then announced that the auction netted \$22,600.00. All this money will go to "White Cane" being credited equally (\$2,825) to each of the eight District Governors White Cane account.

CC Staley then requested that PCC W. Brad Logsdon come forward and give his report on the upcoming 2011 State Convention in Fayetteville, NC. He noted that only 127 people have registered so far but hoped that the numbers would pick up soon. The Ad book stands at \$25,800 toward the goal of \$30,000. He concluded his report by encouraging all those present to attend. (See attachment C)

CC Staley called upon NCLF President Herb Justice for his report. He stated that White Cane contributions are running ahead of last year at this time and have reached 76% of the White Cane Goal of \$777,100.00. He noted that he was pleased with the way our new Camp Director, Susan King, has taken hold. So far, he said, she has completed hiring the counselors for the summer with only 4 to 6 being from overseas. So far we have nearly 600 camper applications for the summer. In closing, he said, the name change to "The North Carolina Lions, Inc." will be presented to the membership at the annual meeting on Sunday. (See attachment D)

CC Staley invited State Convention Chair, Harriett Edmunds to come up to discuss the plans for the 2012 and the 2013 State Conventions. Lion Harriett first discussed the 2012 State Convention. She noted that it would be held May 17 thru 20, 2012 at the Marriott Executive Park Hotel in Charlotte, NC. She stated that the contract had been signed and she thanked PCC Bennie Pugh for all the work he has done and for agreeing to head up the local planning committee for this convention. In talking about the 2013 State Convention she stated that at the last Cabinet Meeting in District 31-D they have approved holding the 2013 State Convention

in their district. Location was not pinned down at this time but the towns of Greensboro and High Point would be considered.

<u>A motion was made by Governor Camajoni to hold the 2013 State Convention in District 31-D;</u> seconded by Governor Thomas. The motion passed.

Before proceeding with the Agenda, Council Chair Staley introduced a matter that had been discussed at the Friday Night Workshop, namely the awards, etc. given to the winners of the Peace Poster, Environmental Photo, and the Celebrate Liberty Contests. After some discussion it was decided that the State Council of Governors and not the State Convention Committee would be responsible for the expenses attributable to the awards received by the respective winner. Accordingly, the following motions were made:

A motion was made by Governor Thomas that the State Council of Governors will be responsible for the costs of the Winners Plaque, \$500.00 U.S. Treasury Bond, expenses of the Banquet and one nights lodging for the Peace Poster Winner and his/hers immediate family; seconded by Governor Suggs. The motion passed.

A motion was made by Governor Womack that the State Council of Governors will be responsible for the costs of the Winners Plaque, \$500.00 U.S. Treasury Bond, expenses of the Banquet and one nights lodging for the Celebrate Liberty Essay Contest Winner and his/her immediate family. Further, the plaque given the Celebrate Liberty Contest Winner shall have inscribed upon it "The Jim Edmunds Memorial Award"; seconded by Governor Thomas. The motion passed.

A motion was made by Governor White that the State Council of Governors will be responsible for the costs of the Winners Plaque and the expenses of the Banquet and one nights lodging for the Lions Environmental Photo Contest Winner and his/her immediate family; seconded by Governor Owens. The motion passed.

Note: After these motions were passed Council Secretary Kelly had a side conversation with Harriet Edmunds where it was revealed that someone donated over \$6,000.00 to the First Flight Lions Club in the name of Lion Jim Edmunds to be used exclusively for the "Liberty Day Celebration." Subsequently, the money was placed in a money market at a local bank. On 05/09/11 a check was received for \$6,750.00 and was deposited in the Council of Governors Money Market Account and designated specifically for use in our "Celebrate Liberty" program.

CC Staley called up the members of the Global Membership team for their updates.

<u>Membership:</u> PCC Gary Greene began his report by noting that we're two months from the finish line and looking at a minus 87 members in the state. We're 173 members short of growing our base by 1% this year, he said. He concluded his report on a positive note by stating

that two of our eight districts are positive this year. Kudos, he said to DG White and District J for being + 48 for the year and to DG Womack and District D at + 20 for the year.

Extension: PDG Larry Gasperson noted that year-to date, seven (7) new Lions Clubs have been chartered this year: two in A, one in D, one in F, two in H, and one in J with a total of 175 (See attachment F) charter members.

Retention: PCC Harvey Whitley stated that retention continues to be an issue in the clubs. Compared to last year at this time, he said, we have dropped more members (913 vs. 844) but fortunately have added more new members (820 vs. 750). We need to continue to emphasize that the keys to improved retention are found at the club level. (See attachment G)

Leadership: PDG Bob Shook announced the first training session with First Vice District Governors-Elect will be held on May 13 & 14, 2011 at Camp Dogwood. (See attachment H)

GMT/MERL Team: PCC Martha Butler noted that we will begin the new Lions Year 2011-2012, with the officially expanded Global Membership Team and the new Global Leadership Team. (See attachment I)

Reports of Statewide Committee Chairs:

Boys & Girls Homes of North Carolina: District Chair Garry Elliott, a graduate of Boys & Girls Homes gave the report. He stated that the renovations to the Lions Cottage have been completed. He also said that the state extension service and the USDA have taken a more aggressive approach to the management of the pecan orchard with the hopes of making it a financial asset to the home. (See attachment J)

Omega/Campus Clubs & Alfa Leo Clubs: (Lions Ken Bucher & Penny Rummel have chosen to combine their reports) Lion Ken Bucher noted that all the goals for the year have been reached with the exception of starting two Leo Clubs in each district. Two \$2,000 LCI Grants were received during the year: one a Leo Leadership Grant, the other one was for the Stop Hunger Now Project. He stated that this year's Leo Convention was a success and was well attended. He stated that the next Leo Convention will be on the last weekend in February 2012 at Camp Dogwood. (See attachment K)

Celebrate Liberty: PDG Mike Covell began his report by reiterating the goals he set for his committee for 2010-2011. He went on to announced the winner of this year's Celebrate Liberty Essay Contest; Ms. Maria Uribe of Crest High School, Boiling Springs, NC. He also discussed the 2011-2012 Celebrate liberty Pins which will feature Thomas Jefferson. (See attachment L)

<u>Constitution and By-Laws:</u> PDG Charles Holleman reported on the changes made to the Policy and Procedures Manual regarding the election of Lions into the North Carolina Lions Hall of Fame.

<u>Diabetes Awareness:</u> Lion Bill Barnwell laced his report with numerous statistics to illustrate the prevalence of Diabetes in the USA. Apparently, he said we are not doing a very good job on eradicating this leading cause of health problems. (See attachment N)

<u>History:</u> Lion Valerie Carpenter announced that she now has paid orders for 376 History Books. In compiling this book, she said, she has received approximately 267 histories out of the 404 Lions Clubs listed. (See attachment O)

Information & Technology: PDG Paul Bledsoe reported on the upgrading of the NC Lions web site, northcarolinalions.org. He cited the flexibility of the site and told us to look for the addition of video and the addition of Facebook. He then went on to discuss the LCI Public Relations Grant entitled "NC Lions a Part of Your Community" "We Make a Difference Every Day."

<u>Lions Alert:</u> PDG Dale Dupree reported that up until April 16, 2011, North Carolina was a safe place to live. That day numerous tornados came to our state and caused extensive damage and he told us of his efforts to contact the North Carolina Emergency Management personnel to see how Lions could be of help.

MD-31 LCIF: PCC Harvey Whitley informed us that subsequent to April 16th when tornadoes wreaked their havoc in parts of North Carolina LCIF Emergency Grants of \$10,000 each were requested and received by the Governors from 31-F,G,H, and J. (See attachment R)

<u>District Governor Womack moved that the State Council approve the Committee Reports;</u> seconded by Governor Camaioni. The motion passed.

There being no further business, the meeting was adjourned at 11:45 AM.

NCLF President's Report to the Council of Governors on April 30, 2011

The North Carolina Lions Foundation is having a good year so far. White Cane contributions are still ahead of last year. We have reached about 76 Percent of the White Cane Goal of \$777,100 and still have two months to go to raise the \$184,982 needed to reach that goal. The Districts contributions run from 56 percent of their goal to a high of 92 percent. The roughest road is still ahead. We are having a good year for Memorials and Honorariums as we are about \$9000 ahead of last year. We need to sell the Lions in the state on making greater use of this tool.

Camp Dogwood ticket sales have picked up and we are now only \$8,000 behind where we were at this time last year. Hopefully this weekend will be a good bonus for us. We still have until the State Convention in June to continue selling these raffle tickets.

Since the last Council meeting we have completed budget hearings and drafted a budget for next year. A Budget Caucus will be held this afternoon to go over the budget to be presented to the Board on Sunday. If you are interested in what the budget contains, please make an effort to attend this caucus. That will be your chance to ask any questions that you may have on the proposed budget. We have also completed Volunteer week. We probably had the largest number of volunteers to attend this year than ever before. We completed a large number of projects, such as the Put-Put Golf course, beautification of the grounds, and the renovation of the Directors house. There is still work to be done on the house, but it should be completed sometime in May. We will still need to schedule the replacement of the roof as it is in need of being replaced. I told you earlier about planting 25 dogwoods last winter, well two of them bloomed this year and all are still alive.

We are pleased with the way our new Director, Susan King, has taken hold. She has some new ideas and is beginning to implement them. We are looking for a good summer camp. A summer camp that we think the campers will find refreshing. Susan King has completed hiring the counselors for the summer with only 4 or 6 being from overseas. She was able to secure the majority of these from within the United States. We still need volunteers for Sessions 2, 3, and 5 and we ask you to publicize this in your newsletters. So far we have nearly 600 camper applications for the summer. So let the people in your districts know that there is still time to apply. We can accept applications up to a couple of weeks before a camper wants to come to camp. We also ask you to put this word out; the cut off time has not passed. Incidentally, Susan King will be here this weekend and will attend the Board of Directors meeting on Sunday, where we will present her to those that not had the opportunity to meet her.

Our realignment of duties for some of the personnel seems to be working good. The promotion of Richard Davis to Facilities Manager appears to be a good move. He is putting a lot of effort into his new job. We also have the Part Time Maintenance worker on hand and he appears to be fitting in well.

The Committee on Committees has completed its study of the NCLF Committees and a summary of these recommendations will be presented at the Budget Caucus this afternoon. A change in the name of the North Carolina Lions Foundation will be presented to the Membership at the Annual Meeting on Sunday. It is recommended that our name be changed to "The NORTH CAROLINA LIONS, INC". We will also be electing the Officers for next year on Sunday.

We hope to continue having a good year. If we provide the Service from the Heart that is needed we will succeed. Thank you for your work this year, you have helped to make this year a success.

MD31 State Membership Report Gary Greene, PCC, State Membership Chair April 30, 2011

We're two months from our finish line and looking at a current minus 87 in the state. This is not a number to be celebrated; our challenge remains to increase membership for the year. We're 173 members short of growing our base by 1% this year.

We've had some successes both at the club and district level. Half of our districts have recruited more than 100 members thus far this year. But only two of our eight districts are plus for the year. Kudos to DG Gwen White and District J – they're at Plus 48 for the year. Kudos to DG Bill Womack and District D – standing at Plus 20 for the year.

As we have said here so many times, we need club Lions all across the state to join in the overall effort to recruit more members. We've got places like the Franklinton Lions Club in District G, starting the year at 14 members, they've recruited 10 new members and now stand at 24. The Pine Level Lions Club and the Southport Lions Club, both in District H, have added 11 new members each. The Massey Hill Lions Club and the Pembroke Lions Club, both in District F, have added 10 new members each. The Kernersville Lions Club in District D has added 10 new members. Winston-Salem Twin City Host has added 17. Lake Lure in District A has added 10 new members.

But it's hard to build membership when we have 181 clubs - 47% of our 380 clubs in the state – failing to recruit a new member this year. 154 of our clubs - 41% – have declined in membership this year.

Retention continues to be an issue in the clubs. Compared to last year at this time we have dropped more members (913 vs. 844) but fortunately have been able to add more new members (820 vs. 750). Our net loss is 93 compared to 94 at this time last year.

We need to continue to emphasize that the keys to improved retention are found at the club level. Many of our clubs are content to do the same old routine whether it is working or not. A prime reason for members leaving is that we fail to involve them in club activities that interest them.

I heard a minister talk about why some churches do not grow and many older churches are not attracting young people. He said that you can have the friendliest church in town but once a member joins they want to be treated with a degree of hospitality. I thought being friendly and being hospitable were about the same thing. He said that being friendly is just being nice to the person but hospitality means proactively getting the member involved into the life of the church and its activities and being genuinely interested in seeing that the member is made to feel a part of the church. Sounds like good advice for our Lions clubs.

We are doing a great job in extension in our multiple district. However, it seems to me that we are losing a lot more clubs than we are forming. I took a look at dropped clubs data over the last two years. A summary of what I found is below. Note the number of older clubs that have been dropped and also note the average years' service of members dropped. We are losing a lot of our valuable Lions assets when these older clubs are dropped. Just food for thought when you are considering trying to salvage a club.

Renovations/updates are completed at Lions Cottage at Lake Waccamaw and boys have moved back in. Clubs are encouraged to make additional donations earmarked for renovations. This will also help build back the reserve fund for future projects in the cottage. Among the improvements were new protected lighting, repainting, carpeting, etc.

A joint civic club project across the state is in the works for the fall which would have individual supporters of Boys and Girls Homes of North Carolina Inc. having fundraising events in their local areas, either in-home dinners or larger events.

It would help them greatly if District Governors would provide membership numbers as of July 1, as that is the basis for club awards. Clubs should also be asked if they would provide president and secretary information so updates can be provided.

- Encourage clubs to hold Celebrate Liberty programs at local elementary schools in March. Several

- Request the By-Laws Committee to make name changes in the by-laws. This request has been made of the By-Laws Committee at this meeting of the Council of Governors.

The following status is reported:

Conduct a statewide Celebrate Liberty Essay Contest: Five District Governors who did not have entries in the Celebrate Liberty Essay Contest graded the three district entries. The winner by a close margin of 3 points of a total of 300 possible points was Ms. Maria Uribe of Crest High School, Boiling Springs, NC. She will be presented with her award at the State Convention and deliver her essay at the Celebrate Liberty forum to held on Saturday afternoon, June 18, 2011.

Hold a statewide Celebrate Liberty program at the Fayetteville state convention: The program will be held at the Airborne and Special Operations Museum in Fayetteville, NC from 2:30 – 3:30 P.M. The winner of the Celebrate Liberty Essay Contest will present her essay and there will be a program on how our American flags incorporated liberty in their designs presented by the Executive Director of The House of Flags, Tryon, NC.

Encourage clubs to hold Celebrate Liberty programs at local elementary schools in March: This is the current focus of District Celebrate Liberty Chairpersons and clubs in their districts.

Request the By-Laws Committee to make name changes in the by-laws: Completed.

The Celebrate Liberty pin, the second in a series of Founding Fathers, representing Thomas Jefferson is the subject of the pin. A sample is provided at this meeting for approval by the District Governors Elect and to solicit the quantities desired by each district for use in 2011-2012.

The only business the Constitution & Bylaws Committee is aware of at this time for the Council of governors is as follows:

A new policy and procedure was presented at the February Council Meeting. The new policy and procedure is in reference to changes made to electing Lions into the North Carolina Hall of Fame. The new policy was listed in the Lions Advocacy for all Lions to see. Unless this Council has information the Committee does not have, then said Council should vote on this new policy.

"North Carolina Lions Hall of Fame"

Purpose: Recognize and Honor the State's most Outstanding Lions

Who Decides: Council of Governors

Number Chosen: The State Council will select up to two (2) fiving and up to three (3) deceased Lions per year from the total nominations submitted for induction into the NC Lions Hall of Fame. At the initiation of this policy six living and/or deceased Past International Directors will be eligible for inclusion into the NC Lions Hall of Fame and will not be counted in the number of two (2) and three (3) deceased living or deceased Lions chosen by the State Council mentioned in sentence one.

Nominations: Any District Governor may nominate and submit a resume for one (1) living and one (1) deceased Lion each year. A standing Hall of Fame Nomination Committee consisting of any current NC International Director, all Past NC International Directors and living recipients of the Hall of Fame Award will serve to assist the Council of Governors in the nomination process. The responsibility of Hall of Fame Nomination Committee will be to annually submit to the State Council additional resumes for up two living and up to three deceased nominations to the Hall of Fame for consideration. All nominations will include biographical information and the qualifications and contributions (presented on the attached form) the nominees made to the goals and objectives of Lionism in North Carolina.

Award Presentation: For the living nominee, the presentation will be made by the recipient of last year's award who will be assisted by the Council Chairperson and the recipient's District Governor. For the deceased nominee, the presentation will be made by the Council Chairperson and the appropriate District Governor to the Family of the nominee if present. If the Family is not present, the District Governor will be responsible for making the presentation to the Family at an appropriate time and place. The deadline for (receipt) of nominations by the District Governors and the Hall of Fame Nomination Committee is January 31st, so that the State Counci! may decide inductees at its February meeting. Submissions should go to the State Secretary/Treasurer for distribution to the District Governors and Council Chairperson. Submissions should include pertinent information about

the nominee including home Lions club, offices held, service activities, honors received, and current status.

Induction: Honorees will be inducted or posthumously announced at the District Governor's Banquet during the Lion's State Convention.

Display of Honorees: Each Recipient's name and year will be shown at Camp Dogwood in an appropriate location. Honorees name and year may be shown on the North Carolina Lion's web site.

Diabetes awareness, apparently we are not doing a very good job.

Why, because in 2009, we had 1.9 million new cases of diabetes diagnosed in the population age 20 and older.

Let me give you some data from 2011 National Diabetes Fact Sheet just recently released.

Prevalence of diabetes.

Total: 25.8 million children and adults in the US--8.3 % of the million people-- have diabetes.

Diagnosed: 18.8 million people

Undiagnosed: 7.0 million

Prediabetes: 79 million

And as previously mentioned 1.9 million new cases in adults 20 years and older.

Under 20 years of age, 215,000 or 0.26% in this age group have diabetes, about 1 in every 400 children and adolescents has type 1

diabetes.

Age 20 and older, 25.6 million or 11.3% of all people in this age group have diabetes.

Age 65 years or older, 10.9 million or 26.9% of all people in this age group have diabetes.

By gender, of the 25.6 million, men make up 13 million and women 12.6 million of the diabetic cases in the US.

What is the economic impact of diabetes in the US?

\$174 billion: Total cost of diagnosed diabetes in the US in 2007.

\$116 billion for direct medical costs.

\$58 billion in indirect costs (disability, work loss, premature mortality).

Diabetes will not go away, it is like a fog rolling down the valley it will gradually cover you. So diabetes at the present rate will become the number one health problem in the US.

From the initial contacts and responses and the information to be gathered as the recovery process unfolds over the coming days, we will learn how to improve our response and to assume our roles more quickly in the future. As in every new program, there is a learning curve; and we are open to every idea, input, and observation that we receive. This is our first time putting our effort into action; and I have faith that our North Carolina Lions will continue to carry the banner "WE SERVE" high.
