Promotions Secretary-Treasurer Kelly was called upon to read the Minutes of the February 14, 2009 Promotions Committee Meeting. <u>DG Gilgo moved to approve the Minutes as distributed by e-mail and as posted on the NC Lions web-site; seconded by DG Mertz. The Motion passed.</u>

PS/T Kelly presented the Financial Report, dated May 1, 2009. Under Income, Kelly called the Council's attention to line Item 510, Promotions Fund, and advised that all Districts have paid their dues for the year. With regard to line item 520, NC Lions Trading Pins, all eight Districts have paid for their supply of Trading Pins. He then pointed out line item 530, Sale of NC Lions Clothing, and noted that, year-to-date; clothing sales met its budget of \$7,500.00. In closing, Kelly stated that the Promotions Reserve currently has a balance of \$24,423.08 (\$6,584.08 Reserve Income and \$17,839.00 in the International Campaign Fund.) DG Martin moved to accept the Financial Report; seconded by DG McAdams. The Motion passed.

Promotions Chair Gasperson reported to the Committee that we will line up for the parade at the International Convention in Minneapolis at 9:00 AM in the "Red Area" and the Parade steps off at 10:00 AM. We are fourth, out of 154, in the line of March. The uniform will be: white shirt, red vest, blue pants, and white shoes. Additionally, a patch supporting Sid's candidacy may be purchased for \$3.00 and sewn onto the vest. Contact DG Dave Martin, next year's State Promotions Chair, if you need patches. If you wear a hat, you will be in the front of the formation. If you wear a cap, or go bare headed, you will march at the rear of the formation.

Unfinished Business:

Promotions Chair brought up the topic of the 2010 Official State Trading Pin. The artwork had been approved and she distributed a production sample for the Committee's approval. It was noted that the outer border of the 2009 pin was white, the 2010 will be red and the border of the 2011 pin will be blue. In the discussion that followed the main concern was the number of pins to be ordered. The current DG-elects will be the ones to decide the amount ordered. For 2008-2009, the Promotions Committee was authorized to order 5,000 pins. Each of the eight Districts being allocated 440 pins, 850 pins were distributed to DG's, VDG's and the International Family, etc. free of charge and 630 were held in reserve. The cost of last year's pins was \$1.64 each and they were sold for \$2.25. Promotions Chair Paulette noted that the 2009 Special Pin cost \$1.46 each and were sold for \$2.00 and the 2010 Official State Pin should be the same. After a protracted discussion, DG Gilgo made the motion to authorize the ordering of 4,000 Official State Trading Pins for 2009-2010; seconded by DG Mertz. The Motion passed.

There being no further business, the meeting was adjourned at 3:45 PM.
