Promotions Chair Martin welcomed all to the Fourth Promotions Committee meeting for 2009-2010. He mentioned that he wished to move through the agenda as quickly as possible so that the majority of the time today would be devoted to the events leading up to the International Convention in Sydney.

Governor Greene moved to approve the Agenda for today's meeting; seconded by Governor Henry. Motion passed. (See Attachment A)

Governor Boudreau moved to accept the Minutes of the February 6, 2010, Promotions

Committee Meeting as distributed to all Committee members by e-mail and as published on the Lions official web site; seconded by Governor Greene. Motion passed.

Promotions Secretary-Treasurer Kelly presented the Promotions Committee Financial Report dated, 04/25/10. He stated that the ledger and the bank account had been reconciled and that all bills have been paid. He noted that all promotions dues have been paid for the year. He then went on to review pertinent line items and concluded with a review of the promotions reserve account.

Governor Greene moved to accept the Promotions Committee Financial Report; seconded by Governor Boudreau. Motion passed. (See Attachment B)

Promotions Chair Martin recognized PID Lacy Presnell for remarks. He noted that we have a list

of the 72 Lions who will be going to Sydney and Lion Brad Logsdon will be directing the assignments. We want everyone to participate in all events they can, he said. This includes the Parade on Tuesday through Friday which will be the Victory Celebration. The District Governors will be our leaders. He then recapped the daily events in detail. There will be a distribution of the two item promoting Sid, he said: 10,000 buttons with the picture of Sid & Judy on them and the 5,000 fountain pens. As there will be between 14,000 and 16,000 attendees to the Convention, he cautioned the group to be judicious in distribution these item. In closing, he reminded everyone attending that there will be a meeting in Asheville during the State Convention where there will be a detailed walk through of each day's events in Sydney.

Promotions Chair Martin then reviewed the Official Parade Uniform for Sydney. The uniform, he said, will consist of white shoes, white socks, navy blue slacks, white long sleeve shirt, red vest, and a white hat.

He then brought up the carrying and distribution of small North Carolina flags during the parade. At the February meeting we approved the purchase of 1,000 small flags. However, as the purchase price today is well over \$1.00 each, he decided to forego this purchase. It was decided that as we had 430 small NC flags currently in inventory, these would be distributed to each District Governor for their delegations.

Lastly, Promotions Chair Martin discussed the Order of March. He went into the positioning of the North Carolina (front right) carried by DG David Osborne and U.S. Flag (front left) carried by PDG Herb Justice as well as the positioning of the Banners. Those wearing hats will march immediately behind the banners followed by those with visors. The North Carolina Lions will be the third to step off, he said.

New Business: Promotions Chair Martin then called up PCC Dave Butler for a discussion of the 2010-2011 State Trading Pin. Lion Dave stated that an order for 5,250 pins was placed as directed by the State Council at the last meeting. The jobber will place the order around June 1st. for deliver by mid-July. The pins will be distributed at the August meeting. He then stated that anyone proposing a design for a pin for 2011-2012 must be submitted by the August meeting.

Promotions Chair Martin concluded his remarks by mentioning that he has compiled a catalog of available clothing inventory available for distribution and has made it available to the District Governors so their Clubs will be able to place orders through them. Turnaround time, he said, should be approximately two weeks after the order is placed.

There being no further business, the meeting was adjourned at 2:00 PM.
