CC Weeks welcomed all to the fourth and last State Council Meeting of the 2011-2012 Lions Year.

Governor Champion moved to accept the Agenda for today's meeting; seconded by Governor Boehm. The motion passed. (See Attachment A)

CC Weeks recognized our International Director candidate Harvey Whitley for comments. Lion Harvey thanked those who have been supportive to both he and Diane over the past several months. He noted that he recently received a call from PIP Sid L. Scruggs, Ill informing him that the International Board has met and has approved his name being placed on the ballot. He then passed around the brochure, designed by Lion Paul Bledsoe, which he will be distributing at the International Convention for all to see. His theme for the coming year, he said, will be "Service, and Then Some." He said that he had a recent conversation with the incoming International President, Wayne Madden, in which he was informed that all the U.S. Delegations would be marching at the front of the parade.

There were no communications.

Governor Lilliston moved to accept the Minutes of February 11, 2012 State Council Meeting as distributed to all District Governors by email and as posted on the website; seconded by Governor Champion. The motion passed.

State Council Secretary-Treasurer Kelly presented the State Council Financial Report dated 04/30/12. He stated that the ledger and bank account had been reconciled and that all bills had been paid. He then reviewed pertinent income and expense line items and then proceeded to review the Money Market Account. He concluded his report by stating that the checking account balance stood at \$28,203.13 and the Council Money Market balance was \$78,642.03. Total assets, therefore, were \$106,845.16. Governor Sutton moved to accept the Financial Report; seconded by Governor Boehm. The motion passed.

CC Weeks recognized PCC Ron Staley for his report on the status of the 2012 Lions State Convention to be held at the Marriott Executive Park Hotel in Charlotte on May 17-20, 2012. He was happy to report, he said, that the State Convention Committee had finalized most of the details for the convention. He reported that ads were received from both Lions Clubs and businesses totaling slightly over \$25,000. His one concern, however, was that the deadline for Convention room reservations was May 12th (tomorrow). He urged that those who hadn't done so to please make that call today. He then reviewed all the sightseeing activities that were planned. A list was distributed containing the names of the Lions from District 31-E who were members of the Convention Committee indicating the sub-committee they headed. He asked that if we saw one of these individuals to please take a minute to thank them for their hard work. He also passed out a copy of the Convention Agenda that will be printed in the Convention Program.

CC Weeks recognized State Convention Committee Chair, Lion Harriett Edmunds. Lion Harriett reported that she has contracted with the Greensboro-High Point Marriott Airport Hotel for the 2013 State Convention. The dates are May 17-19, 2013, she said. She noted that PDG's Paul Bledsoe and Bill Womack will be the local co-leaders for this convention. She then addressed the First Vice-District Governor's-Elect telling them that she has received a proposal from the North Raleigh Hilton for the State Convention in 2014. They have space available the first weekend in May, she said. She remarked that the only thing needed to close this contract is for the Raleigh Clubs to step up and agree to host this convention. She left her cell phone # and e-mail address should that want to contact her.

Council Chair Weeks recognized North Carolina Lions, Inc. President, Stewart Wooten for his report. Lion Stewart began his report by listing, and then explaining, what had been accomplished at Camp Dogwood and North Carolina Lions, Inc this past year. He cited fifteen accomplishments with the most prominent being the revision of the Matching Funds Policy, the purchase of a new Vision Van, the increase in offseason use of Camp Dogwood, the increase in the number of summer campers, and the new Ad Hoc Committee on Fund Raising.

Council Chair Weeks recognized MD Global Leadership Coordinator PCC Ron Staley for his report. He began his report by noting that so far this year LCI and the Southeastern Global Leadership Team have made

available an unprecedented number of training opportunities. Online webinars for the training of Presidents, Secretaries, and Treasurers have been conducted and were well received, he said. In addition to the webinars at the International and Regional levels, Lion Ron stated that State GLT Coordinators will soon be offered an account where they can set up and host their own webinar sessions. He closed by saying that he can foresee that some of the DG Leadership Training will eventually migrate to the webinar in the very near future.

Council Chair Weeks recognized PCC Gary Greene, our MD Global Membership Coordinator for his report. Lion Gary began his report by noting, for the record, that we started the year at 8,319 and now stands at 7,989 for a net loss of 265 members. He then proceeded to describe the membership activities in the individual districts in MD-31. He closed his remarks by recognizing Lions Charles Holliman and Bob Walton from District J as the only active Guiding Lions in the State who are shepherding the only new Club organized so far this year in North Carolina. He went on to say that they are also halfway to forming another new Club in Lucama and have so far booked 10 new members for that Club. He noted that while we certainly need new clubs in the state, equally important is the need Lions to step forward and become Guiding Lions.

Reports of Statewide Committee Chairs:

Boys & Girls Homes of North Carolina: PDG Theresa Matthews was unable to attend. No report submitted.

<u>Campus Clubs/Leos/Youth Exchange:</u> Lion Liz Steele reported that the Leo Convention held on February 24/25/26^{th.}, at Camp Dogwood was very well attended. They elected new officers at the convention, she said. She went on to thank the District Governors for both their financial and moral support throughout the year. She reported that three new Leo Clubs were formed this year and that another club, in District 31-A, was currently planning their Charter Night. However, she said, two Leo Clubs were cancelled in District D and one in District E due to inactivity over the past year.

Celebrate Liberty: PDG Mike Covell began his report by reiterating the three goals his committee has established for the Lions year 2011- 2012. He reported that Districts 31A, 31F and 31G are participating in the Statewide Celebrate Liberty Day Contest and that District 31E's Celebrate Liberty Chairpersons, Sarah and Braxton Troublefield will be coordinating the awards ceremony at the State Convention. He noted that the Celebrate Liberty pin for 2012-2013 will honor James Madison, the father of our Constitution. In closing, he stated that in order for the Celebrate Liberty Program to flourish in MD-31, the District Governor's need to give their wholehearted support to making the program a success.

<u>Constitution & By-Laws:</u> PDG Charles Holliman reported that his Committee has no outstanding requests from the State Council of Governors for today's meeting. He noted that the revised "North Carolina Lions Hall of Fame" policy was passed in February and that at the General Membership Meeting at the upcoming State Convention, the Lions of North Carolina will vote to add the Diabetes Awareness Committee to the Multiple District 31, Constitution and By-Laws.

Diabetes Awareness: Lion Bill Barnwell was unable to attend. No report submitted.

<u>Historian:</u> Lion Valerie Carpenter introduced Lion Gwenn White who advised us that the first three sections of the History Book have been sent to the publisher. Two sections are yet to go, she said. She noted that they have ordered 500 copies of the book and that 480 have been purchased. A discussion followed regarding "tribute pages."

Information Technology: PDG Paul Bledsoe announced that we have received the final phase of the \$10K PR Grant. He went on to discuss how the campaign would be deployed throughout the State in the individual districts. He advised the Governors that they had a \$1,750 matching grant available if they wanted to apply for it. He concluded his remarks with a discussion of Internet marketing.

At this point in time, Council Chair Weeks noticed Dr. Lacy Presnell had just entered the meeting room and ask if he would like to make any comments to which Dr. Presnell responded "Happy to be here!"

<u>Lions Alert:</u> PDG Dale Dupree commented on the Tornado that hit Central North Carolina in March and the response made by District 31-E in its aftermath. He still considers Lions Alert to be a work in progress. He concluded his remarks by noting that he is investigating joining VOAD (Voluntary Organizations Active in a Disaster).

<u>MD LCIF Coordinator:</u> PCC Harvey Whitley began his report by reminding us that LCIF continues to give back to our Multiple District in the form of grants. Here in North Carolina, he said, we have experienced recent aid through Emergency Disaster Grants for tornados and hurricanes. The balance of his report centered on the challenge LCIF received in October 2011, from the Bill & Melinda Gates Foundation. This initiative, called "One Shot, One Life: The Lions Measles Initiative." He noted that MD-31 ranked 11th in the US in donations to this initiative. In his written report he listed each district and their contribution.

A motion was made by Governor Hopkins to accept the Committee Reports as reported; seconded by Governor Champion. The motion passed.

New Business:

NC Lions MD-31 Council of Governors Meeting Minutes

- (1) CC Weeks advised that all those going to the Breakfast at the International Convention in Buson need to turn their money in as soon as possible.
- (2) SST Kelly, with reference to the North Carolina Hall of Fame, summarized the Friday Workshop discussion where it was decided to change how the awards are presented at the annual Lions State Convention. The State Council has decided that the awards to the "Living" recipients will continue to be announced and presented at the District Governor's Banquet at the annual State Convention. However, with regard to the presentation to the "Posthumous" recipients, the award announced will be announced at the District Governor's Banquet but will be presented at a special event in the recipients home district. Further, the Council decided that the Hall of Fame Committee outlined in the Policy & Procedures Manual should be changed to read: The Hall of Fame Committee shall consist of the sitting District Governors. This Committee will be chaired by the State Council Secretary-Treasurer. This change, he said, would be sent to Lion Charles Holliman, Chair of the Constitution & By-Laws Committee for inclusion in our Policy & Procedures Manual.
- (3) SST Kelly then summarized the Friday Workshop discussion regarding the accumulation of funds in the State Council Money Market account for Youth Exchange. Districts are not invoiced annually for this program, Kelly said. Rather, two districts, 31-G & 31-J have been sending in \$500 annually to this program while the other districts merely sent in \$500 on a voluntary basis when solicited at the beginning of each fiscal year. The fact that the Youth Exchange Program has been inactive for the past few years has prompted The District Governors of 31-G & 31-J to ask for the return of the \$500 each has sent in this year. Governor Champion moved that the State Council Secretary-Treasurer return the \$500 that Districts 31-G and 31-J sent in this fiscal year for the Youth Exchange Program; seconded by Governor Buchter. The Motion passed.

Comments from Audience/Lions:

PCC Charles D. Smith addressed the Council and discussed the fine job that Boys & Girls Homes has been doing in caring for the children that are sent to them. He noted that these were hard times for the Home and asked Lions to consider helping out financially if they could.

(Note) Subsequent to this State Council Meeting, Council Chair Weeks polled the Council regarding the request of Council Chair-Elect Wayne McGohan to go to the International Convention in Buson, Korea rather than attend the International Convention in Homburg, Germany at the end of his tenure in 2013. The State Council voted unanimously to approve this change.

Adjournment: The meeting was adjourned at 11:17 AM.

Since the last council meeting online webinars have been offered for Secretaries, Treasurers and Presidents. The training for secretaries and treasurers included an overview of the new online membership report which will be rolled out in July. Hopefully we will get the word out to most of these officers. For club secretaries who have not been informed of the new system, this change will a shock. I am counting on the District Governors and the District GLTs to inform and see that the secretaries are trained.
- Training in Goal Setting for North Carolina's District Governors Elect and GMT/GLT coordinators was held on April 26. I hope all of our leadership took part in the training.
- In addition to the webinars offered at the International and Regional levels, State GLT coordinators are being offered an account where they can set up and host their own webinar sessions. This means that sometime in the future I will have the capability, at no cost to our Council, to offer webinar classes to our Lions in North Carolina. I think this will provide numerous opportunities for holding meetings and training classes of up to 100 participants without asking Lions to travel to a physical location. As soon as I have the account and have been trained we should be able to begin. With this capability there will be all sorts of possibilities that we have not enjoyed before. Who knows we may be holding some of the DG training by webinar or possibly having regional training sessions by the end of next year. I do understand learning to use the system requires a lot of training so it will be a while before we can begin holding the sessions.

Everyone is familiar with our membership numbers in North Carolina. For the record, we started the year at 8,319 and now stand at 7,989 with a net loss of 265 members — equivalent to 13 clubs. District J continues to be our shining star — forming one new club — and now stands at Plus 3 for the year. Efforts continue across the state in our other districts. Few are resting.

- District J is halfway to its second new club. Lucama has at least eight charter members thus far.
- District H hosted an Extension Workshop in Beaufort and has 17 members thus far. A branch club in Jones County also has 17 members. Two clubs with fewer than 15 members have been raised to more than 20 while two more have been raised past 15.
- District G is getting closer to a campus club at UNC Chapel Hill.
- District F has efforts under way for a new club in Fayetteville, one new Campus Club, and a
 possible Champion Club with the Special Olympics.
- District E is celebrating the mid-point of a new club in Monroe through an Extension Workshop.
- District D and District B continue to work toward improving retention of current members.
- District A is working on a new club and has seven members signed up thus far.

Lastly, one of the statewide teams that may be formed under the GMT Chairmanship is the Club Success Team. This team of two to four Lions focuses on engaging Lions in community service activities and identifying new service project opportunities. I envision that this team could take the lead in recognizing the best of the best of our clubs throughout the state. I welcome any volunteers who would like to join with me to make this a reality.
