# MD31 North Carolina Lions Promotions Committee Minutes

# Saturday, August 12, 2006

# Holiday Inn, Salisbury, NC

The Meeting was called to order by Promotions Committee Chair Michael Allman at 1:00 PM

District Governor Bob Roland gave the Invocation and Allman led the Pledge of Allegiance.

Allman thanked the Lions and guests in attendance and stated his goals for the coming year. He recognized PID Sid Scruggs for comments.

Scruggs commented on the extra \$2.00 per Lions dues assessment for the International Officers Campaign. The assessment which began on July 1, 2005 will runs through June 30, 2011. His home district of 31-F has pledged to meet the 1250 minimum members by the November Council meeting. He is grandfathered as a viable candidate through the 2007 Chicago International Convention. He will seek endorsement at the NC State Convention for the 2008 and 2009 Conventions. Unfortunately, the 2008 Convention in Thailand is expected to be very expensive which may hinder NC Lions from attending.

Scruggs was not opposed to a joint breakfast with South Carolina for the Chicago Convention; however, we should hold our own caucus. The NC delegation hotel is the Drake and will be shared by Ohio, South Carolina, Alabama, Arkansas, Australia, New Zealand and Indonesia.

Scruggs encouraged fund raising efforts beyond a tax on the membership. He will provide memorabilia items for silent auctions at the individual District Conventions.

Kelly was asked to serve as Parliamentarian.

Immediate Past Promotions Chair Pat Roland gave her final report. Total sales of promotion items during 2005-2006 amounted to \$10,670.18. At the beginning of the year, the Administrative Account had a deficit of \$3659.05, but ended with a positive balance. The ending balance of International Officers Campaign Fund is \$35,433.96.

LCI recorded 113 Lions and guests attended the Boston Convention from North Carolina. Since she accompanied DG Bob Roland to the Convention Roland could not maintain the Hospitality Room. She thanked PCC Brad Logsdon for maintaining the Hospitality room in her stead.

Page 1 of 7 Attachments A & B Due to problems with arrangements, Logsdon recommended a site inspection for Chicago, including looking at local restaurants for a breakfast site.

Roland transferred clothing items valued at \$1387.31 to this year's Promotions Chair Michael Allman. (See attachment "A")

DG Roland moved to approve the 2005-2006 Promotions Committee Report; seconded by Flora. The report was approved.

PCC Diane Whitley commented that attendance was poor at each of the North Carolina and South Carolina Hospitality rooms. The SC delegation who also experienced low attendance shared their food with us on the last day of the Convention.

PDG George Ohm, Promotions Secretary-Treasurer, presented the 2005-2006 Year-end Financial Report. The ending balance in the administrative Account was \$6507.58 with \$35,433.96 in the International Officer's Campaign Fund. Total assets including a CD, clothing items and excess pins amounted to \$43,477.57. (See Attachment "B")

# Kelley moved to approve the 2005-2006 Year-end Financial Report, seconded by Butler. Motion Passed.

Ohm presented his proposal for a balanced 2006- 2007 Promotions Committee Budget. We are looking at reduced income from dues because of loss in membership; also we ordered fewer trading pins than before previous years. Ohm went over the budget line by line indicating that at certain times of the year he has to dip into reserve funds to pay bills on the administrative account before Administrative income is received.

Several questions were raised regarding the appropriateness of certain items in the Promotions Budget including the VDG blazers, jacket crests, and allowances to attend the International Convention. Suggestions were also made to hold the proceeds of the Tail Twisters Breakfast at the State Convention to bolster the Promotions Administration fund. <u>The Committee decided to</u> <u>table the budget until the November meeting.</u>

Allman stated that the North Carolina delegation hotel will be the Drake with rates of \$169.00 per night. He urged the Lions of North Carolina to stay together in the same hotel. If a bus tour is formed it should insure that Lions will stay at the delegation hotel. He questioned whether we should have a Breakfast or a Hospitality room. He was asked to look into these at a later date.

Allman stated that all 2007 "Rafting" Trading pins have been distributed along with an invoice. He asked that the invoice be paid as soon as possible to bolster the treasury.

One design has been submitted for the 2008 Trading pins, "Fishing". He asked for additional designs for the committee to consider for the November Meeting

Allman proposed a 50/50 Raffle to be run by the Promotions Committee at each District Convention. Several started that the individual districts would have to be approached for permission to run the raffle.

Page 2 of 7 Attachments A & B Leathers moved to allow the Promotions Chair to approach the District Convention Committees to request permission to run a raffle during the convention. . Sandy seconded the motion. Motion passed.

Allman complemented PDG Roland on selling down the clothing stocks, but now he needed to order more stock. His first order will include gold, purple white shirts and ball caps.

Since the budget was not approved, Roland moved to allow the Promotions Chair to purchase new clothing items as required to re-stock the promotions inventory. Dupree seconded the motion. Motion approved.

Allman asked if we should consider a new marching uniform. Butler commented that PID Scruggs was reluctant to change for fear of burdening Lions with extra cost. Several complained that the red vests were hot and the color bled through. It was decide to table for the next meeting.

PDG Bill Udovich stated that when he was District Governor in 1984-1985, they sold 18,000 pins resulting in substantial income for the Promotions Committee.

Udovich reminded the Committee that when PID Scruggs is elected as 2<sup>nd</sup> Vice President his need for funds will continue through his Presidency, so we need to continually look towards means for raising funds.

Sandy requested that we prepare a catalogue of NC Lions Logo Items to be given to all of the clubs in the state. He had good success just selling from samples he took to clubs, including \$4.50 for shipping. Roland suggested that we place the logo items on our web-site for lions to order. Allman is already working on a catalogue.
