Council Chair Carlton Weeks called the first meeting of the 2011-2012 North Carolina State Council of Governors to order at 9:00 AM.

District Governor Michael Schwartz led the Pledge of Allegiance and District Governor Jim Boehm gave the Invocation.

For the record, the Council held a Workshop on Friday evening, August 12, 2011. All eight District Governors were present at the Workshop and at today's Council of Governors Meeting.

CC Weeks welcomed all to the first State Council Meeting of the 2011-2012 Lionistic Year.

Governor Hudson moved to approve the Agenda for today's meeting; seconded by Governor Walton. Motion passed. (See Attachment A)

Vice Council Chair, DG Schwartz read the slate of Council Chair Officers elected at the International Convention:

<u>Governor Champion moved to approve the Council Officers; seconded by Governor Boehm. Motion</u> passed.

CC Weeks then recognized PID Lacy Presnell who said that he was happy to be here to see all the smiling faces.

PCC Dave Butler agreed to serve as Parliamentarian.

There were no communications.

Governor Lilliston moved to accept the Minutes of the May 3, 2011, State Council Meeting as distributed to all District Governors by e-mail and as posted on the web site; seconded by Governor Hudson. Motion passed.

Council Secretary-Treasurer Kelly presented the 2010-2011 year-end Financial Reports. He reviewed and explained each line item regarding income received during the past year. On the expense side, he concentrated his discussion on those line items that exceeded budgeted amounts, i.e., line 310, State Convention cash advance/expenses, which exceeded budget by \$9,000 due to the need of the Convention Committee to subsidize meal prices. He also noted the \$1,730 over budget amount on line 440 due to Committee Chairs not requesting funds during the budgeting process and yet getting funding for projects during the year with State Council approval. (See Attachment B)

Governor Sutton moved to accept the 2010-2011 year-end Financial Reports; seconded by Governor Boehm. Motion passed.

Council Secretary-Treasurer Kelly then presented the proposed 2011-2012 budget. Starting with line item 110, State Dues, Kelly noted that for the upcoming year the dues number is predicated on the average number of NC Lions for the year as being 8,584 members; this compares to last year's budget number of 8,850. He then proceeded to explain each of the line items under Income. In reviewing the Expense line items, Kelly pointed out the upward adjustments made to office supplies and postage to reflect last year's experience. He stated that line item 290, Expenses-State Secretary/ Treasurer, would be reduced to \$2,500.00 for the same reason. The expenses for the Council Chair (line item 300) would be adjusted downward to reflect last years experience and line 305 reduced to zero as this expense was moved back to the 2010-2011 fiscal year to reflect the incoming Council Chair, Carlton Weeks, going to the International Convention in Seattle rather than to Buson, Korea for the 2012 Convention. Lines 320 through 429, which contain mainly State Council Committee Chair requests for funding, Kelly said, are in line with last year's requests. The remainder of the expense line items deals with clothing items for the State Council and are in line with last year's budget, Kelly said.

Council Secretary-Treasurer Kelly then proceeded to review the Money Market Account which, as of 08/08/11, had a grand total of \$77,586.50. The breakdown of the account, he said, was as follows: State Convention Reserves, \$32,134.93; Celebrate Liberty, \$7,959.45; Youth Exchange, \$6,810.46; State Council Reserves of \$28,921.49; and a LEO Club's balance forward of, \$1,738.43. Interest earned on the account last year totaled, \$847.08. (See Attachment C)

Governor Hudson moved to accept the 2011-2012 Budget as presented; seconded by Governor Hopkins. Motion passed.

Council Secretary-Treasurer Kelly requested approval to continue our relationship with RLI Surety Co. for the State Treasurer's and Promotions Committee Treasurer's Bonds as well as the Statewide Blanket Bond for the District Cabinet Treasurer's and the State Convention Treasurer. He also requested that the Pinehurst Branch of First Bank be approved as the depository for all State Council and Promotions Committee funds.

Governor Buchter moved to approve RLI Surety for Council, Promotions, Cabinet Treasurers, and State Convention Treasurer Bonds and that the Pinehurst, NC Branch of First Bank be the depository for Council & Promotions Committee funds; seconded by Governor Schwartz. Motion passed.

Council Chair Weeks welcomed all the 1st & 2nd Vice-District Governors in attendance and asked them to stand and be recognized. He then opened the floor for the District Governors to speak about the "State of their District." A summary of their remarks follows:

<u>District 31-A:</u> DG Randy Champion started by saying that he was optimistic about his District. His goals for 31-A this year, he said, will be to charter two (2) new Clubs, obtain a 5% growth in membership, have each Club be plus one for net growth, and thus a net plus 54 members for the district. He is working closely with his Zone Chairs this year and has asked them to be the liaison between the District and the Clubs. He said that he made a commitment to IP Wing-Kun Tam to plant 1,200 trees in his District.

<u>District 31-B:</u> DG Helen Hudson stated that she too was going to get her Zone Chairs more involved with their Clubs this coming year. With the theme, "Sailing into Humanitarian Service," she said her humanitarian, education and life enrichment goals for the year were: to work with the Lions of her District to retain current Club members, to attain new members, and to work to strengthen weak Clubs. She plans to promote the work and activities of Lions in their communities.

<u>District 31-D:</u> DG T. Michael "Mike" Hopkins stated that his District has already held their Leadership Training and their White Cane Kickoff. He said that his main goal for the year was for a net gain in District membership this year with all clubs attaining a net gain of at least one new member per Club. He noted that if each Club and Zone held at least one membership meeting this goal could be reached. In addition, he would like to charter at least one new Club and one new Leo Club.

<u>District 31-E:</u> DG Michael Schwartz said he plans to have his 1st & 2nd Vice District Governors very involved this year because he will be pushing a rebuilding program with all his Clubs this year. Having seen the loss of four Clubs last year and a membership drop from 1,350 to 1288, membership growth has to be emphasized for 2011-2012. He has set a goal of \$167,500 this year for the White Cane Drive, he said. With the death of PDG Benny Pugh, PCC Ron Staley, PDG Dale Dupree, and PDG David Smoot have volunteered to serve as co-chairs of the State Convention which will be held in May in Charlotte.

<u>District 31-F:</u> DG Denning Buchter said that he plans to develop a new District website and to use local newspapers to tell the story of the lions in 31-F. He will be pushing to see a minimum of one new Club in the District and that each Club has a net gain of one new member. He also would like to see each of his Clubs add one new service project this year. He said his District is in the process of forming three (3) new Branch Clubs and one new Club in the Fayetteville area. He mentioned that the District has begun a monthly video called "Lions Pride" which Lions Clubs International has placed on their website as a favorite. As a way to strengthen his Clubs, he said that he encourages them to get involved in the Club Excellence Process (CEP).

<u>District 31-G:</u> DG Andrew Lilliston started his remarks by saying his theme this year is: "Keep Our Eyes On The Ball." He went on to say that, like other District Governors, he too was getting his 1st & 2nd Vice District Governors heavily involved with administering the District.

<u>District 31-H:</u> Rick Sutton stated that his goals for the coming year are as follows: a net increase in membership of two (2) new members per Club; the District will charter a minimum of one new Lions

Club and a minimum of one new LEO Club. In addition, he said, each Club should have a membership drive at least once this year. Communications are important, he said, and so he is encouraging each Club to publish a Club Newsletter that would include information from the District Governor's Newsletter.

<u>District 31-J:</u> DG Jim Boehm noted that he had four membership goals for the coming year. The first goal is that each Club will recruit at least one new member per quarter and to recruit them without discrimination. The second, he said, to hold a Fall and a Spring Extension Workshop and to organize at least two (2) new Lions Clubs. The third is to reduce the number of dropped members by 25%. Lastly, he said was the District needed to identify and train future District Leadership.

Council Weeks thanked the District Governors for their Reports. He then announced the need to appoint a Secretary-Treasurer for the Promotions Committee.

Governor Hudson moved to appoint PDG Ron Kelly as the Promotions Committee Secretary-Treasurer for 2011-2012; seconded by Governor Hopkins. Motion passed.

Council Chair Weeks asked the Council to review the list of State Council Statewide Committee Chairpersons that was distributed and to advise if it is correct. Hearing no corrections he called for a motion to approve.

<u>Governor Schwartz moved to approve the State Council Statewide Committee Chairpersons for 2011-</u> 2012; seconded by Governor Buchter. Motion <u>passed</u>.

Council Chair Weeks called on PCC W.Brad Logsdon to give the Final Report of the 2011 State Convention.

PCC Logsdon summarized the activities of the 2011 State Convention held at the Holiday Inn, Fayetteville, NC, on June 16 through 19, 2011, as a very hot, hot time he said. Other than for a failed Air Conditioning system, he felt that they had a very successful convention. Fun Night was attended by 271 Lions and Guests. The Tailtwister Breakfast and Auction, attended by 251 Lions and Guests. The District Governor's Banquet was attended by 376 Lions and Guests with an address by LCI President Lion Sid L. Scruggs, III. He noted that the Committee was waiting for some checks to clear and some additional income to be received for a final accounting. His best estimate at this time, he said, will reflect a profit of \$6,000/\$7,000. In closing, he said that a Final Report of the 2011 State Convention will be made at the November State Council Meeting. (See Attachment E)

Council Chair Weeks called on PCC Ron Staley to give a report on the 2012 State Convention Plans.

PCC Staley stated that since the untimely death of PDG Benny Pugh, the local planning committee for the 2012 State Convention will now be handled jointly by PCC Ron Staley, PDG Dale Dupree, and PDG David Smoot. All the contracts have been signed to hold the 2012 Lions State Convention from May 17 thru 20, 2012 at the Marriott Executive Park Hotel in Charlotte, NC, he said. A Golf Tournament has been arranged to be held at Regent Park in Fort Mill. Lion Staley then announced that Judge Haynes Townsend has agreed to be the State Convention Keynote Speaker. He stated that planning was progressing and that the projected income stood at \$60,000.00 and expenses at \$54,000.00. Meal prices were comparable to those of the past few years. When the question of meal subsidies was raised, Lion Ron said that the subject had not as yet been considered. A discussion then ensued regarding a

convention pin and it was decided that a sufficient number of the Official State Pins would be purchased for inclusion in the registration packet. A motion was made by Governor Champion that the Official State Trading Pin would be the pin used by the Convention Committee for inclusion in the registration packet; seconded by Governor Sutton. Motion passed.

Council Chair Weeks recognized Lion Harriett Edmunds for her report on the status of the 2013 Lions State Convention. Lion Harriett announced the District 31-D has agreed to host the 2013 State Convention at the Best Western Hotel, in High Point, NC. The dates are May 16 thru 18, 2013. She met with the management of the Best Western and secured an \$86.00 room rate which includes a free continental breakfast. They will allow us to bring in food for our Hospitality Room and they also will provide free parking. A motion was made by Governor Hopkins to hold the 2013 Lions State Convention at the Best Western Hotel in High Point, NC from May 16 – 18, 2013; seconded by Governor Buchter. Motion passed. With regard to the chairperson to head the local planning committee for this convention, a motion was made by Governor Hopkins that PDG Paul Bledsoe and PDG Bill Womack would serve as Co-Chairs; seconded by Governor Champion. Motion passed.

Council Chair Weeks recognized North Carolina lions, Inc. President, Stewart Wooten for his report. Lion Stewart reported that the Executive Committee is undergoing a study of all the committees with the thought of combining and/or eliminating some of them. As an example, he said that the Vision Van Committee could be eliminated while the LEHP Committee could logically become part of the Diabetes Awareness Committee. He also discussed two new Committees: Camp Dogwood Office Services Committee, and Camp Dogwood Activities Committee. He then mentioned that the Speakers Committee is being reactivated. Last but not least he noted that a person has been retained to begin a Grant Writing Program.

Council Chair Weeks recognized Global Membership Chair Gary Greene for his report. PCC Gary began his report by saying that we are one month into the new Lions Year and we've lost 42 members already. He then said, "Let's start moving the membership numbers in a different direction for a change." He said he was convinced that the only way we can see real membership growth in North Carolina is by having more feet on the ground—more people who are willing to serve as Rebuilding Lions, Guiding Lions, and Club Mentors. Our goal this year, he said, is to attain a one percent gain in membership in the state. Your GMT chairs do not accept that membership will continue to decline in North Carolina. No one in this room accepts that declining is acceptable. By working together, by asking our past governors to step up and help in our districts, by using resources such as the extension team from Lions International, by constantly encouraging our club presidents and zone chairs and, by working closely with our district governors, we shall have a positive year for membership growth this Lions year.

Council Chair Weeks recognized the MD Global Leadership Coordinator Bob Shook for his report. PCC Bob stated that his primary responsibility this year will be the District Governor Training. In addition, he plans to implement the new goals and strategies that were explained at the Clayton, Ga., GLT Leadership Workshop. He said that he was in the process of developing a 2nd Vice District Governor Training Session. Also, he plans to initiate Certified Guiding Lions training in each of our eight districts. This needs to be done as soon as possible, he said, so the efforts of the GMT will not be held up.

<u>New Business:</u> PID Lacy Presnell was recognized and requested that MD-31 prepare a resolution endorsing PID Joe Preston of Arizona for the high office of Second Vice President of Lions Clubs International. <u>A motion was made by Governor Lilliston that State Council Secretary-Treasurer Ron</u>

Kelly prepare a resolution stating the MD-31 endorses PID Joe Preston of Arizona for the high office of Second Vice President of Lions Clubs International and see to it that it is mailed to the appropriate recipients; seconded by Governor Boehm. Motion passed.

Unfinished Business: None.

Council Chair Weeks then called for the Reports of Statewide Committee Chairs.

Reports of Statewide Committee Chairs:

Boys & Girls Homes of North Carolina: PDG Theresa Mathews listed the goals of her Committee as twofold: Build awareness of the plight of vulnerable children across the State and to promote the support of the charitable agencies that serve them, and, increase NC Lions Club support for the Lions Cottage and the programs at Boys and Girls Homes at Lake Waccamaw. She has asked her district chairs, when they make Club presentations, to inquire what other homes for children are min the area and what support Lions provide.

Campus Clubs/Leos/Youth Exchange: Lion Liz Steele opened her remarks by stating that she is attempting to ascertain the viability and/or inactivity of the Leo Clubs throughout the State. As this information is slow on coming in she has asked the District Governors for assistance. Her goal is to have the district chairs concentrate on the Alpha Leo Clubs (ages 12-18) and Omega Leo Clubs instead of the Campus Clubs. She would like to create on average two new Leo Clubs per district. With regard to the Leo State Convention, it is planned to take place at Camp Dogwood from Friday February 24 through Sunday February 26, 2012. They will offer, as a Leo Project, "Stop Hunger Now." As they did last year, she is asking the District Governors for financial help in raising the \$2,500.00 to fund this project. A motion was made by Governor Schwartz that each District contribute \$312.50 each to support the "Stop Hunger Now" Project at the Leo State Convention; seconded by Governor Hudson. Motion passed. In closing her remarks, Lion Liz announced that due to the large balance in the Youth Exchange Money Market Account she would not be asking that each District contribute the customary \$500.00 this year. (See attachment I)

<u>Constitution & By-Laws:</u> PDG Charles Holliman announced that he has not received any requests, so far this year, to make any changes to our Constitution and By-Laws.

<u>Diabetes Awareness:</u> Lion Bill Barnwell reported on some recent statistics on the increase in Diabetes in the U.S. and noted that in North Carolina 9.6% of the 18 and older population has been diagnosed with diabetes ranking us as the 13th highest in the USA. (See attachment J)

<u>Historian:</u> Lion Valerie Carpenter reported that she now has orders for 385 History Books. (See Attachment K)

<u>Information & Technology:</u> PDG Paul Bledsoe began his report by telling the District Governors that it was now time to prepare plans for the 2nd phase of the LCI Public Relations Grant of \$10,000.00. The Governors need to decide, he said, how this 2nd phase of the Grant should be spent. He noted that there were several considerations: A) Should each district receive an allocation of \$1,250.00, B) Use the 10K as a whole budget and allocate for the best media penetration across the state, C) Create more printed material for use throughout the state, or D) Create more visual/electronic materials for districts. Our goal, he said, is continued awareness about our work and developing a network that reaches out to

the electronic media and the social networks. He concluded by saying that he would need their help in this endeavor.

<u>Celebrate Liberty:</u> PDG Mike Covell did not attend the meeting, however he did submit a report by email. In his report he stated that his committee has established three goals for 2011-2012: 1) Involve each District in the statewide Celebrate Liberty Essay Contest, 2) Hold a statewide Celebrate Liberty Program at the State Convention in Charlotte, and 3)Encourage Clubs to hold Celebrate Liberty programs at local elementary schools in March 2012. He noted that the second commemorative pin in a series honoring Thomas Jefferson has been produced. Each District, he said, has received 62 pins for sale and distribution within their District. In closing he said that the subject of this year's Celebrate Liberty Essay Contest is a quotation from Thomas Jefferson: ": The democracy will cease to exist when you take away from those who are willing to work and give to those who would not. It is incumbent on every generation to pay its own debts as it goes."

<u>Lions Alert:</u> PDG Dale Dupree said that the Lions Alert part of the North Carolina Lions is a continuing work in progress. He noted that he has made contact with other volunteer organizations that are active when disaster strikes as well as the Red Cross to coordinate relief services. (See attachment N)

MD-LCIF: PCC Harvey Whitley said that the primary goal of his committee was to educate and improve the message to our Lions about the impact that LCIF has in the world. He said we should not forget that LCIF has helped us here in North Carolina in building dorms at Camp Dogwood and in providing medical equipment for Clinical Eye Research. (See attachment O)

<u>Nominations:</u> PDG Bob Sprinkle announced that, to date, two Lions have submitted their names for the position of Council Chair for 2012-2013. They are PDG Wayne McGowan and PDG Gary Steele. For the position of Council Secretary-treasurer to only applicant is the current Secretary-Treasurer, PDG Ron Kelly. Nominations will close September 30th, he said. (See attachment P)

<u>Promotions:</u> PDG Gary Steele, while deferring the majority of his comments until this afternoons Promotions Committee, he did want those attending the meeting to know that he had a great variety of Lions shirts available for sale.

Research and Long-Range Planning: PDG John T. Miller, III stated that his committee has not met as yet this year as it awaits any charge the State Council may request. The committee has one open charge from last year regarding developing a plan for consideration regarding the Recreational Facility and Conference Center. (See attachment Q)

Council Chair Weeks called for a motion to accept all State Council Committee Reports.

Governor Buchter moved to accept all the State Council Committee Reports; seconded by Governor Boehm. Motion passed.

There being no further business, the meeting was adjourned at 12:12 PM.

Boys & Girls Homes Committee August 12 – 13, 2011 Theresa Matthews

Goals

Build awareness of the plight of vulnerable children across the state and the promote the support of the charitable agencies that serve them.

Increase Lions Club support of the Lions Cottage and the programs at Boys and Girls Homes of NC Inc. at Lake Waccamaw.

To Accomplish:

Ask district chairs when they make presentations at clubs to inquire what other homes for children are in the area and what support Lions provide.

Promote "For the Kids", a civic club challenge for October to raise funds for Boys & Girls Homes of NC at Lake Waccamaw. Also the raffling of picnic tables being made by the reinstated vocational program and clubs registering for Belk Charity Days on behalf of Boys and Girls Homes at Lake Waccamaw if they do not already participate.

Attached is "For the Children" information on being a part of the fundraiser/PR tool. Also "The Child of Yesterday/The Client of Today" which points out how different the needs of vulnerable children are today.

Additional information for "formal" report:

Boys and Girls Homes of NC Inc. at Lake Waccamaw is a home for children that are not accepted at all other children's home because of the need for Theraputic Care. A large percentage of those children require drug and psychological treatments and counseling due to physical, emotional, and sexual abuse. In the past year, a 12-year-old girl was admitted – she was being prostituted by her mother for money so she could buy drugs.

BGHNC is also making strides in foster care, providing Theraputic Homes for children with greater needs. They also provide training and support for the foster parents and help with adoptions. This outreach service is in many counties not just at Lake Waccamaw. Already starting with year-round school, BGHNC plans to become a charter school, especially due to the special needs of their children. In regular school, suspensions due to behavior problems are not in the best interests of the BGHNC children. They need more encouragement, more counseling, and being kept on track and working. As a charter school they can be kept on task but not interfering with the other students.



THE CHILD OF YESTERDAY THE CLIENT OF TODAY

In the 50's, 60's & 70's:

Culture: The child had limited access to media and it had more positive adult role models with healthy values

Education: The child knew that learning was valued and discussed as a way to "get ahead" or be successful

Behavior: The child, due to better adult supervision. was involved only in minor infractions with the law such as petty larceny stealing truancy peer fighting minor chemical issues such as glue sniffing etc

Referrals: The child came directly from the birth family to BGHNC

Relationships: In many cases the child had some adult attachments within the birth family and could transfer those attachments to BGHNC staff and build upon a foundation of relationships

Future: The child had viewed or had a conception of goals based on experiences of some appropriate adults and had generalized techniques about how to grow into a functional adult

Trust: The child was able to gain a high level of trust with BGHNC staff

Contact: The child had personal contact with adults which was acceptable and a real part of respect with professionals

Funding Resources: Many children came under the endowment funding from the Home

Role Models: BGHNC direct care staff members were seen as a role models and father/mother figures and when the child became an adult, as a long-term friend The staff had minimal training but felt "called" to provide love, care and safety to children

David D. Passmore, Ed M. Vice-President of Residential Services



Now:

Culture: The client is exposed to many forms of media with toxic messages including sex, violence, destructive behavior and drugs.

Education: The client is more likely to drop out of school due to multiple placements and the lack of consistency lowers the chance of proper schooling

Behavior: The client is more likely to find a sense of belonging in gangs and crimes consist of home invasion, murder, violence, armed robbery and assault

Referrals: The client has had 8-10 previous foster care placements prior to coming to BGHNC

Future: The client has had negative adult role models and was taught no positive values which challenges today's staff to successfully provide positive role models with appropriate values

Trust: The client has no trust level with adults. including the BGHNC staff

Contact: For the client's safety, trust and a positive environment, limits and boundaries need to be very clear and consistently enforced

Funding Resources: All clients are now funded by DSS state contracts

Role Models: All BGHNC staff members must act in a manner that promotes the client's health and wellbeing, and make responsible ethical choices in relationships with clients. Direct care staff members need extensive training to successfully assist clients in helping them change what they believe about themselves in order to bring about permanent changes in their behavior

I am working on setting up visits to each of the districts and to meet with Leo's, chairpersons and advisors. The Leo clubs information is slow in coming so we need the Governors assistance.

My goals for the year are as follows...

My goal would be to have the district Leo chairs concentrate on the Alpha Leo Clubs (ages 12-18) and Omega Leo Clubs instead of Campus Clubs. (We will not do away with existing Campus Clubs)

My goal is to create on average two new Leo Clubs per district. They will be either Alpha or Omega and either community or school based clubs. DIABETES AWARENESS

Good Morning Governors and fellow Lions:

I would like thank you for the privilege of serving you and the Lions of NC for another year. Many of you have heard me since 2005 talk about the increase in the incidence of diabetes. In 2004 just under 8 percent of the population of NC had diagnosed diabetes, now we have 9.6 percent diagnosed diabetes in the 18 and older population. In 2000 NC was ranked 17th in the USA in the number of cases, now we are ranked 13th. With the diagnosed, undiagnosed, and pre-diabetes cases combined, NC has over one(1) million, 200 thousand residents 18 and older with diabetic problems. In 1995, NC's percent of diabetes was 4.5, now our percentage has increased to 9.6 %. This is an increase of over 100% in 15 years.

The goals of the committee are:

- (1) Provide programs for as many clubs as possible,, at least 30 %.
- (2) Ask clubs to continue on going projects offering screenings and education on diabetes prevention.
- (3) Ask clubs to start projects on diabetes prevention.
- (4) Ask clubs to coordinate with local health organizations on general screening projects.
- (5) Work with your local hospital education center at their health fairs.

We must strive to meet our goals to decrease the burden of diabetes on our population.



We worked with the major companies across North Carolina. The companies included Lamar, Fairway and Adams Outdoor. Installation fees ranged from \$125 to \$325.

We want to set up a way that we can implement our plans and facilitate getting the right people to the right places at the aright time.

LCIF continues to make a powerful impact on the lives of millions of people throughout the world. This can only happen with our continued financial support. Our goal this year was to raise an additional \$30 million and we were able to raise \$48.5 million. Another success we had this past year was offering Contributing Membership pins through our District Coordinators rather than by mail order. The sales of these pins doubled. Thanks to those who have shared the story of LCIF and all the good that is being done through our Foundation.

Last year, 36 LCIF grants totaling \$440,000 were used for emergency grants here in the United States, mostly for tornado and flooding relief. We need to keep in mind, as we consider goal setting for the coming year, that we in North Carolina are frequent benefactors of this type of relief from hurricanes and tornados.

The primary goal of this committee is to educate and improve the message to our Lions about the impact that LCIF has in the world. Not only is LCIF a resource for emergency and disaster relief, but standard grants are available for such things as buying sight equipment, building medical centers and Habitat homes, and providing equipment for playgrounds for the disabled. Don't forget also that LCIF helps us here in North Carolina to build dorms at Camp Dogwood and provide medical equipment for Clinical Eye Research.

For 2011-12, we are beginning a partnership with the Gates Foundation called Measles Initiative. The goal is to vaccinate 41 million children for measles. Our Lions need to know about these types of projects and I urge you to include mention of the work of LCIF in your District Governor's club visits.

We look forward to another successful year at LCIF with Immediate Past International President Sid Scruggs serving as Chairperson.
