Report of the Council Chairperson:

Greetings from the 2016-2017 MD-31 Council of Governors. Across North Carolina, this year, citizens have seen our motto, "We Serve!" in action, and they know, without a doubt, that "Where there's a need, there's a Lion."

Four of our five districts have had to deal with the effects of natural disasters, a hurricane and its aftermath in the east and wild fires in the west. All four districts received Emergency Assistance Grants from Lions Clubs International.

According to the December District Health Assessment...

- Year-to-date, across the state, we are down one club, having gained two clubs, Greater Morganton in District L and Ashokie Centennial in District S, and we have lost three clubs, one each in Districts I, O, and N. All of our District Governors are continuing efforts to add new clubs, bring in new members, and retain the current members in their districts.
- Current membership, statewide, is: 6288, down thirty-eight from a month ago.
- The average number of members per club is holding steady at twenty-one, as is the percentage of clubs with less than twenty members (57%). Although all of our districts except one are still over 1,250 members, we need to continue both to add new clubs and to grow existing clubs. As always, we need to stress that more members means that we can provide more service to those in need.

Curent membership trends convince me that, although many people recognize what Lions do in their communities and beyond, many more do not know who we are and what we do. If they did, I believe that people would be lined up to join us. We have to continue and expand our service. We need to take on centennial projects and signature projects that will cause people in our communities to take notice. We can not continue to be a well-kept secret. We need let our communities hear us roar!

**Treasurer Report** 

Under PERMANENTLY RESSTRICTED ASSETS, on page 1, investments show a total of \$ 1,481,384. This is an increase of \$ 100,000 compared to last year same time. This number is pretty much flat since my November report. Obviously this depends on the market fluctuation.

If you look at the Income Statement Summary on page 5, you will notice that the expenses exceed our revenue by \$78,942. This is still normal for this time of year and is actually better than the year to date budgeted amount of\$165,568. It is also \$228,782 better than the same time last year.

Looking at the relationships between the Unrestricted Revenue and the Unrestricted Expenses, the total under Unrestricted Revenue shows that the actual amount is \$42,454 greater than the budgeted amount. Under Unrestricted Expenses the budgeted amount exceeds the actual spending by \$ 43,494. So, to this point of the year we have taken in more funds and we have spent less than we budge

The last item I would like to, once again, bring to your attention is found on page 11. This being the total for Office Expenses. \$ 9, 979, continuing, to be under Budget. I feel we need to give Steve and all his staff a big thank you for this.

The faculty and staff of UNC Kittner Eye Center extend their gratitude for the major impact NC Lions have made on the eye care of those who come to UNC for a variety of eye diseases. Most recently NC Lions have provided state of the art equipment to relieve the pain and discomfort that occurs to those patients with dry eye symptoms.

The NCLI funds were deposited to UNC Eye in December 2016. The equipment is now in place in the Cornea Service and the Lions International plaque to recognize their support of the grant will be placed near the equipment.
