Camp and Retreat Administrator's Report: Lion Tammy presented the Camp report. (See attachment 2.) 1st VP Karl stated that the executive committee had endorsed all campers and staff receive vaccine or wait until next year.

Question was raised concerning counselors' ability to receive vaccine due to their ages. Lion Tammy has spoken with representative of the county health department who gave her guidelines to aid the counselors in receiving the vaccine. Additional discussion was held regarding the legality of denying participation in summer camping season without receipt of Covid vaccine. DG Allen Swaim will investigate further.

Additional resolutions would have to be made to accommodate virtual ballots to approve the changes. President Curtis recommended that changes be returned to committee for resolutions to be reworded.

A voice vote was undeterminable. Roll call vote revealed 3 yes votes and 12 no votes; motion failed.

- Camp Dogwood: PDG Wayne Faber reported. PDG Marti Henry is working to promote raffle sales in Districts L & I. PDG Wayne is covering the other districts. Raffle ticket sales are progressing but do need to push. He thanked clubs for stepping up to meet the needs at Camp Dogwood. All HVAC units needing replacement have been updated with the exception of the largest unit needed for the Coleman Cates room.
