NCLI Board of Directors Meeting NCLI November 14, 2020 Zoom Meeting

NCLI Board Meeting was called to order by President Curtis Erickson at 2:30pm.

Opening Remarks: President Curtis thanked everyone for attending via zoom, acknowledging the changes necessary due to the NC Governor's mandates reducing in person gatherings to 10 people or less. President Curtis recognized the excellent job during a "roller coaster year" done by Executive Administrator Durden's and Camp Administrator Tammy's efforts to cut expenses in this challenging year. Most of the staff has been furloughed, being brought back as needed to help with events at camp. Due to the most recent state guidelines, the employees have once again been furloughed. Some of the early spring activities at Camp (like volunteer week) may be delayed due to the pandemic restrictions. Clubs started the year off well at the Brighter Visions kickoffs. Bookings for off season events are vital to the financial health of the camp. All staff members and the executive board will be monitoring expenses as we go forward.

Introductions: Lion Curtis acknowledge on-line presence of PIP Sid Scruggs, PID Harvey Whitley, and PID Gwen White. All expressed their pleasure to attend.

Reading and Approval of Minutes: Motion made by Lion Bob Block to accept minutes as distributed. Lion Neal seconded the motion which carried.

Role Call: All Board Members were present with the exceptions of 2nd VDG Marilyn Wunderler (31-L), PDG Nathan Medlin, and At-Large Director PDG George Suggs. Committee chairs not in attendance nor submitting reports were PDGs Wayne Faber, and Marti Henry.

Appointment of Parliamentarian: PDG Dave Butler agreed to serve.

Camp and Retreat Administrator's Report: Lion Tammy presented the Camp report. See attachment 2. Motion to accept report by Lion Carlton, 2nd by Lion Ken Beach. Motion carried.

Executive Administrator Report: Lion Durden reported that Tracy Neil Brown had named NCLI as a beneficiary of his life insurance in the amount of \$8,000.00. Mr. Brown was a non-Lion who was impressed with several Mount Pleasant Lions. Lion Durden wanted this information preserved in the Board's minutes.

Kudos to the staff for keeping the camp up and running. Expenses for the 1st 4 months of this Lions year are down \$153,258 from the same period last year.

Lion Durden noted that VSP vouchers are helping clubs to offset lack of matching funds for the rest of 2020. 300 vouchers were sent to NCLI by LCI. The vouchers cover all eye exam and eyeglass expenses for adults and children. Clubs may contact Bryan Hoover for more information and availability of the vouchers.

The Stickley Endowment was established in August 1989 with the earned interest to be used for administrative expenses. At the August NCLI Board meeting, the board approved withdrawing annually 5% of the total account. That amounts to a \$7300 monthly draw which has helped meet current payroll expenses.

The \$48,000 grant from the Foundation of the Carolinas has been used to purchase a screening van vehicle. Lion Durden has acquired approximately half of the equipment for the van.

A grant has also been submitted to the Sisters of Mercy in western North Carolina.

He is cautiously optimistic that Congress will enact another Covid stimulus program and payroll protection program by the end of January, hopefully sooner.

The Brighter Visions report has been modified to reflect the past 3 years history, hopefully providing more information for district governors and Brighter Vision chairs to work with clubs. The raffle report has likewise been modified. Lion Durden thanked NCLI accountant Eileen Artavio for her diligent work on these reports.
