PCC Gary informed the Council that our cost for our Website Hosting and Domain Name fees has increased and we need to consider who is paying for this. The cost per year is \$86.50 for the Hosting and \$19.56 for the Domain Names per District, except for District L because they already pay for there own hosting. Lion John Lynde has negotiated a two year fee for the Hosting with InMotion Hosting at \$863.78 and a three year fee for Domain Name at \$255.06. This will make the annual fee \$106.06 for the State and Districts I,O,N,S and \$19.56 for District L. The Council elected to charge this on a yearly basis.
