QUARTLY REPORT

August 9, 2025





On April 25th I held a pre planning meeting with my cabinet, chairpersons and zone chairs at Lions Industries for the Blind, Kinston. It was a great opportunity for everyone to get acquainted.

Twenty-three Lions attended with 5 attending via zoom.

We discussed duties of zone chairs and they being the link between the district governor and the clubs.

The Following District Governor goals were reviewed, discussed and agreed on:

- The district will raise \$15,000 for LCIF.
- 100% of zone chairs and 80% of Club Officers will be trained.
- 60% of clubs in 31-N will report service projects.
- By the end of the 2024-2025 Lion year, our district will start 2 new clubs and will achieve a +50 in membership growth with a net gain of 38 members

It was recommended that the district submit a Grant to Lions International for \$10,000 to renovate and improve the District Disaster Trailer.

We discussed suggestions for a second global cause for 2025-2026. Children's Diabetes was favored.

Training session dates throughout the year were presented and approved.

Because many of the previously purchased vision screeners are out of warranty a suggestion was made to consider submitting a district grant to LCIF to purchase vision screeners by individual clubs.

Our efforts to raise \$10,000 to support a \$20,000 grant through LCIF are going well. Over \$5,000 has been raised and the grant paperwork has been sent to the LCIF board for approval. A 5K fun run is scheduled for October 25th in Greenville to raise funds to support the grant.

Our GET coordinator PDG Mayra McCloud is working on two new clubs and we have hopes of forming a new club in Washington NC.

Already this year I have attended one zone meeting and another zone chair has schedule meetings with all clubs in that zone.

Our Brighter Visions Kickoff and First Cabinet meeting are scheduled for August 16th.

The year has started and we're up and running.

It's an honor to stand before you today as your multiple district coordinator for Lions Clubs International Foundation, the charitable arm of our great organization. LCIF is more than a name-it's a lifeline. It's the force behind our global impact and the partner that empowers us to serve when our communities need us most.

Let me begin with a number that speaks volumes: \$3.5 million.

That's how much LCIF has awarded to North Carolina in grants and project funding. That's not just money-it's meals served, homes rebuilt, children helped, and lives changed.

And here in Multiple District 31, we've seen that impact firsthand. Last year, LCIF awarded our state:

- \$30,000 in emergency grants and a \$100,000 major catastrophe grant, both in response to Hurricane Helene, helping us provide immediate relief and long-term recovery for those affected.
- LCIF has already said that if we need another \$100,000 major catastrophe grant for hurricane relief, the money is available.

I know many of our clubs redirected their fundraising efforts last year to support hurricane relief-and I commend you for that. Your compassion and responsiveness are what make Lions who we are.

But now, it's time to reinvest in the Foundation that made that support possible.

Last year, clubs and individuals across Multiple District 31 contributed \$301,649 to LCIF.

District 31-L: \$5,772.92

District 31-I: \$18,857.10

District 31-0: \$21,211.69

District 31-N: \$16,615,62 District 31-S: \$20,109.98

That's a start—but we can do better.

Some of you who are math wizards will note that the amounts that I just mentioned doesn't add up to \$301,649. In fact, it totals \$82,567.31. The other \$208,549.60 contributed to LCIF last year came from non-Lions or were donated anonymously. The bulk of those contributions came from the estate of a North Carolina woman named Betty Jane Willis, who was from Mt. Airy. Some of you may remember Mrs. Willis as she often appeared on the Betty Feezor

Show on WBTV. Mrs. Willis had designated part of her estate to go to our Foundation when she died in 2023. Her bequest to LCIF was through our planned giving program. When you include LCIF in your estate plan, your generosity makes sure we can continue to bring volunteers together to serve their communities, meet humanitarian needs, encourage peace and promote international understanding. If you're interested in this program, let me know or visit the LCIF website under ways to give.

So let me talk about our multiple district goals. Today, I'm asking each club in Multiple District 31 to consider a simple goal:

Donate a minimum of \$10 per member to LCIF this year. Some clubs and district donate a whole lot more to LCIF. But with roughly 4,237 members as of July 1, that would raise \$42,370 for LCIF — a meaningful amount that strengthens our ability to respond to future disasters, support youth programs, fight hunger, and preserve sight.

But giving is only part of the story. Recognition matters too.

Did you know that 3,372 Lions in Multiple District 31 are on the LCIF rolls are having received a Melvin Jones Fellowship? 287 of those Melvin Jones Fellows are progressives. That's a whole lot of Lions whose dedication has been honored through one of the highest forms of recognition in our organization. North Carolina is the 9th largest multiple district in Constitutional Area 1 when it comes to Melvin Jones Fellowship. It requires a \$1,000 contribution to receive one—meaning North Carolina Lions clubs have contributed \$3.6 million to LCIF to honor a club member.

And here's something important:

Our clubs currently hold \$318,355.82 in undesignated funds at LCIF. These are donations already made—but not yet assigned to a specific purpose. I've reviewed the report, and some clubs have thousands of dollars in undesignated funds that could be used to award a new or progressive Melvin Jones Fellowship. Use this money or give a new contribution this year.

So I'm asking each club in Multiple District 31 to do two things this year.

1.Make a contribution—at least \$10 per member

2.Award at least one Melvin Jones Fellowship or a Progressive Melvin Jones Fellowship—to honor a Lion whose service deserves recognition. That would recognize a minimum of 244 Lions who deserves our recognition.

Supporting LCIF is not just about funding—it's about fulfilling our mission and celebrating our members. It's about showing the world that the North Carolina Lions are committed, compassionate, and ready to lead.

Let's make this a year of generosity.

Let's make this a year of recognition.

Let's make this a year where Multiple District 31 stands tall in support of the Lions Clubs International Foundation.

Thank you for your service. Thank you for your heart. And thank you for being Lions.

2025 NC Lions State Convention Recap

It is our privilege to give you the final report for your 2025 State Convention as well as some details for your 2026 State Convention.

First, our heartfelt thanks to PDG Laraine Dupree and her phenomenal convention committee. They did a superb job and made your 101st NC Lions State Convention one to remember.

We have some numbers for you...which is always exciting 318 registered attendees

\$22,000 in program ad sales

And a net profit of \$13,966.65 all of which will be put towards the cost of meals for our 102nd convention. None of this money will be spent on anything else! This exceeds previous years by almost \$5,000.

With that in mind, once again all registered attendees will have a free lunch on Saturday. Also, thanks to our Past District Governors Organization, registered attendees will have a free grab and go breakfast on Sunday, served by your PDGs. Thank you so much.

PDG Barbara Thompson and I are honored to serve as your 2026 Convention Host Committee Co-Chairs. We met with the Council on Wednesday, via zoom, to review an email that was sent to them earlier. This email explained the two items that needed to be voted on today by the five District Governors and we were able to address any questions and concerns.

The first item to be voted on is the final convention budget and the results of the audit performed by PCC Gary Greene. Copies of both were distributed to the councils. There is a difference of \$632 in the bank balance and the convention profit. That represents the amount of money to be returned to the Council from the administration fund for the past two years. The exact amount of the check will be slightly less (about \$10)as one additional receipt was recently turned in. We are officially asking the Council Treasurer to forward the 2026 NC Lions Council State Convention Committee a check for \$4,226 which represents \$1.00 per lion in North Carolina for the convention administration fund, from the dues collected for the North Carolina Lions State Council and State Convention Fund. This money can only be used for specific administrative expenses.

Please vote now on the approval of the audit.

The second item to be voted on by the five current District Governors, is the person or persons that the 2026 NC Lions Council State Convention will be dedicated to. This has already been discussed and no name will be mentioned at the time of this vote, but will be disclosed at the appropriate time.

Our convention team will be meeting to discuss plans and ideas for 2026. Watch for some changes and lots of fun. Remember we will be gathering, once again at the Greensboro High Point Marriott Airport on April 17-19, 2026. We can't wait. Technology Devices for the Visually Impaired and Blind

Since the May meeting our committee members continue working toward Lions' goals and service areas to assist with the technology devices and low vision aids.

The outgoing state chair spent a week in June in District L. We visited the McCune Center and attended a zone meeting in that area. We also visited the Etowah Lions Farmers' Market. Lion Michelle spoke at the Mills River Lions Club. It was a rewarding and wonderful week in the Asheville area.

Lion Michelle demonstrated the eSightgo glasses to a lady in Winston Salem in July. I retested her on August 8th during a zoom call with the eSight representative, Carolyn Bradley. This individual has decided to try the "at home" telehealth visit. It gives her about one week with the device and virtual training with the eSight Team.

Lion Michelle and her husband PDG Jimmy will be visiting Waynesville on August 15 and 16 to demonstrate the eSightgo with a gentleman. If the device proves successful, he will be recommended for the telehealth trial. He is a veteran. If he should decide to purchase, then the VA will be contacted as they will pay for the device.

PDG Mark Bateman was able to demonstrate the eSightgo to several of our campers at Camp Dogwood the week he and his wife volunteered. He has contacted several previous visually impaired individuals that tested well on the old eSight unit. Several had positive demonstration experiences with the new unit. He is working on funding for these individuals.

Lion Jim Jansco has received a grant for his club, Lake Gaston, to purchase several WeWalks to donate to our visually impaired. I believe UNC Wilmington provided the funding for the grant.

PDG Mayra continues to speak with clubs, libraries, health fairs and anywhere she can to promote all the items we know about that can assist the visually impaired.

The Durham Lions Club working with a local library held an event with the <u>Grandpa's White Cane</u> storybook in July.

PDG Sharon Weddington is transitioning into her new role as state chair of this committee. Thanks to the Lake Gaston club, they have provided her with a WeWalk. We are in communication with Lion Jim to assist with scheduling the training that is offered by WeWalk. She send her regards and regrets that she couldn't attend this weekend. She is on a family vacation.

Please remember that October is White Cane Awareness Month and the 15th is the actual day. Please plan an activity with your club; possibly one that uses the children's book, Grandpa's White Cane.

It's not too late to sign up on the Enchroma website to receive two free pairs of Colorblind correction glasses in September. September is Colorblind Awareness month.

I have recently learned of the Blindshell cellphone and in the beginning stages of researching it. It was recommended by one of District I's VIPs.

NC Lions 2025 State Convention

I have reviewed financial materials that provided a complete accounting of the transactions undertaken for the 2025 NC Lions State Convention from September 6, 2024, through May 31, 2025. These transactions included all income generated for the event as well as a detailed listing of expenses. The convention treasurer is responsible for the preparation and fair presentation of these financial statements in accordance with the accounting principles generally accepted in the United States.

I reviewed the First Citizens bank statements and randomly cross checked deposits against the Excel sheet showing the event's running balance. All reviews demonstrated accurate accounting. The convention financial committee provided a thorough breakdown of expenses across 24 categories as well as income across eight categories. There was also a breakdown of administrative expenses and revenue.

The conclusion of my review and that I am not aware of any material modifications that should be made to the financial statements and records. I express my heartfelt appreciation to our Lions leaders who undertook this task on behalf of all the Lions of North Carolina.
